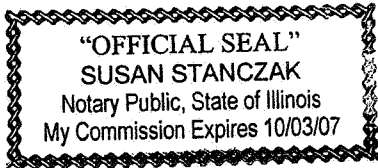

- Provide labor for temporary relocation of office staff, and equipment.


