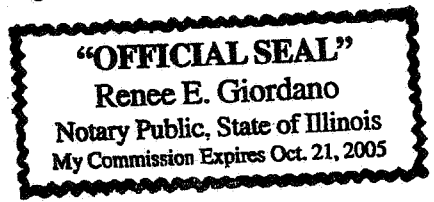

The scope of work to be performed under this sub-order shall be to lower an existing 48" water main and to support it with two thrust restraint structures.

The complexity of this additional work requires a highly specialized contractor. The special thrust restraint system was beyond the expertise of our General Contractor on this project. The urgency of this work due to late fall season called for the selection of the JOC contractor to perform this work as soon as possible. Proceeding under the traditional bid/award process for a separate contract would not allow the completion of this project and the opening of 43rd street to thru traffic.
