1.	Please describe the major features of the project:
	The bridge houses roofs of the Halsted Street, Chicago Avenue, 95 th Street and Torrence Ave bridges are leaking on to the mechanical gears and requires immediate repairs. Also required is cladding and emergency repairs to the Bridge houses. This cannot be performed by City Forces and is not covered by an existing term agreement. It is for these items that we are requesting the use of a Job Order Contract.

	These bridge house roofs require immediate repairs. It would not be time or cost effective for us to perform the work through the City's traditional bid process.
