RE: CDA Commissioner Jamie L. Rhee – Recusal - **UPDATED**

DATE: March 1, 2019

Jamie L. Rhee, Commissioner of the Department of Aviation (“CDA”), has recused herself from the management of any contract under which Cable Communications, Inc. (“CCI”) and McDonagh Construction, LLC and McDonagh Demolition, Inc. (collectively “McDonagh”) are performing work, including, for example, contract modifications, extensions of time, vendor limit increase requests, and contract disputes. All contacts regarding the management of those contracts must be with a designated person in CDA senior management and will be determined by me as General Counsel of CDA.

In addition, Commissioner Rhee has recused herself from all Invitation for Bid and Request for Proposal processes in which CCI or McDonagh has been identified as a participant, either as a prime or a subcontractor, and, should a contract be awarded to the team on which CCI or McDonagh is a participant, Commissioner Rhee is recused from the management of those contracts, again, including, for example, contract modifications, extensions of time, vendor limit increase requests, and contract disputes. All contacts regarding the management of those contracts must be with a designated person in CDA senior management and will be determined by me as General Counsel of CDA.

The Department of Procurement Services ("DPS") has advised that, based on DPS's systems of record, CCI is a participant on or has participated as a subcontractor on the following CDA contracts: PO Nos. 17866, 13016, 28297, 16844, 26443, 26441, 46920, 12098, 7998.

DPS has advised that, based on DPS's systems of record, McDonagh is a participant on or has participated as a subcontractor on the following CDA contracts: P.O. Nos. 78287, 64418, 64584, 55230, 35223, 26340, 8866, 15034, 27075, 29926.

Commissioner Rhee also is recusing herself from the management of any contract under which Montel Technologies, LLC is performing work, including its work as a subcontractor under CDA's contract with Hartmann Electric, Specification Number 130180A/Project Number H9016.14-00, and any disputes arising thereunder.

Commissioner Rhee also is recusing herself from the following CDA contract disputes in her capacity as CDA Commissioner:

PO 13280, Maintenance and Repair of Terrazzo, Mondo Terrazzo;

PO 41944, Chicago Midway International Airport Runway 4R-22L Rehabilitation, K-Five;
