

A communication recommending eighteen (18) proposed ordinances concerning the authority to approve the levy of taxes, to approve or amend Special Service Provider Agreements and to approve the 2014 budgets for various Special Service Areas.

B. A proposed ordinance authorizing the imposition of a tax levy, the approval of the 2014 budget, and the approval of the Service Provider Agreement for Special Service Area Number 3. Amount to be levied: \$1,228,968 - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.

A communication recommending eighteen (18) proposed ordinances concerning the authority to approve the levy of taxes, to approve or amend Special Service Provider Agreements and to approve the 2014 budgets for various Special Service Areas.
