**Committee on Finance**

**A communication recommending a proposed ordinance authorizing an Amendment to a previously executed Redevelopment Agreement with Theus Holdings, LLC. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**

**A communication recommending a proposed ordinance concerning the authority to enter into and execute a Loan Agreement and certain fee waivers for WCS Preservation Associates, LP. Amount of Loan not to exceed: \$2,964,968. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**

**A communication recommending a proposed ordinance authorizing the issuance of Recovery Zone Bonds for Asphalt Operating Services of Chicago, LLC. Amount of Bonds not to exceed: \$45,000,000. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**

**A communication recommending a proposed ordinance concerning the authority to enter into and execute a Loan Agreement, to issue Tax credits and issue bonds for Oakwood Senior Apartments. Amount of Bonds: \$13,000,000 and Amount of Loan: \$3,000,000. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**

**A communication recommending a proposed ordinance concerning the authority to issue City of Chicago General Obligation Tender Notes in an amount not to exceed: \$80,000,000 and declaring intent to issue Tax-exempt bonds in an amount not to exceed \$600,000,000. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**

**A communication recommending a proposed ordinance concerning the authority to enter into and execute a Redevelopment Agreement with Voice of the People in Uptown, Inc. and the Community Housing Partners X, LP and to approve the issuance of a Tax Increment Allocation Revenue Notes in the collective amount of \$2,500,000. - Alderman Burke shall abstain from voting on this item because he has represented some of the parties involved in this ordinance in previous and unrelated matters.**
