**CITY COUNCIL APPROVES MARK A. FLESSNER  
FOR CORPORATION COUNSEL**

Chicago City Council today approved Mayor Lori Lightfoot's nomination of Mark A. Flessner for Corporation Counsel for the City of Chicago.

"The City of Chicago needs and deserves a Corporation Counsel as experienced, talented and committed to public service as Mark Flessner," said Mayor Lightfoot. "His knowledge and expertise in a wide range of legal areas is matched only by his desire to serve the public and create a better Chicago for all residents."

Prior to being Corporation Counsel, Flessner was a partner and trial attorney at Holland & Knight, a global law firm with more than 1,300 lawyers and other professionals in 28 cities across the world, including Chicago. He has more than three decades of professional legal experience handling sophisticated matters across numerous industries, including finance, healthcare, insurance manufacturing and retailing. Flessner also has extensive trial experience, which includes bringing more than 50 cases to verdict and arguing more than 40 cases on appeal.

"I am excited and honored to be Corporation Council and for the opportunity to step forward and serve as the City's chief legal officer," said Flessner. "Throughout my career, I have worked in both the public sector and private sector and look forward to returning to government and leading a talented group of professionals who have a significant impact on our residents' quality of life."

At Holland & Knight, Flessner's practice focused on representing clients facing government scrutiny for criminal, civil and regulatory matters. He advised clients with respect to complex commercial litigation, internal corporate

investigations, grand jury inquiries and issues involving the Foreign Corrupt Practices Act.

In addition, Flessner represented the firm's local government clients in federal civil rights actions. He also donated significant legal time to pro bono activities and was the pro bono partner for the Chicago office. He also served as a member of the Federal Defender Panel in the Northern District of Illinois, providing legal representation to the indigent. Prior to entering private practice, he was a federal prosecutor at the United States Attorney's Office in Chicago, where he led major investigations involving sophisticated and complex financial fraud.
