We are writing to request the consideration of the Department of Planning and Development-Historic Preservation Division and the Commission on Chicago Landmarks (CCL) to begin the formal designation process seeking a Preliminary Landmark Recommendation for Promontory Point.

This amazing park and landscape is situated on a peninsula within Burnham Park, and many in the community and larger City, would like to have this considered for Chicago Landmark designation at the next meeting of the Commission on December 8, 2022.

We're attaching the Preliminary Landmark Recommendation Report prepared by landscape preservation consultant Julia Bachrach, which details the historic value of Promontory Point and lists the criteria for designation. In September 2021, Preservation Chicago presented Promontory Point as a "Suggestion for Landmark," after nominating Promontory Point as a Chicago 7 Most Endangered as part of our Chicago Lakefront in March of 2021, and individually as a most endangered site in 2021.

We are sure that you are aware of how important and beloved Promontory Point is to the immediate neighborhood, the South Side and City-wide residents and why all want it preserved and declared a Chicago landmark.

In her statement to the *Hyde Park Herald* in August 2022, Mayor Lori Lightfoot endorsed a preservation approach to any future repair, restoration and rehabilitation at Promontory Point. In fact, all relevant elected representatives endorse preservation at the Point: U.S. Representative Robin Kelly, Illinois State Senator Robert Peters, Illinois Representative Curtis Tarver, Cook County Commissioner William Lowry. And Alderman Leslie Hairston, who has insisted on preservation for 22 years, has now sent you a letter requesting official City-landmarking.

The following organizations are also in full support of Chicago Landmark designation of Promontory Point, including Landmarks Illinois, the National Trust for Historic Preservation, Friends of the Parks, Openlands Chicago, Hyde Park Historical Society, the Cultural Landscape Foundation, us at Preservation Chicago and others.

Unanimous support of preservation in the community, from preservation organizations and from all elected representatives naturally leads to a Chicago Landmark designation of the existing historic limestone revetments, the Alfred Caldwell landscape design, and the Buchsbaum pavilion. These park features and their astonishing beauty won Promontory Point its listing on the National Register of Historic Places in 2018 and deserve the highest level of appreciation and protection from the City of Chicago.

Like Lincoln Park's Alfred Caldwell Lily Pool, a National Historic Landmark and a Chicago Landmark, Promontory Point is equally unique, important and deserving of Chicago landmark status. It is an historic, Prairie School landscape in Chicago by world-class landscape architect Alfred Caldwell. The Point is also the only remaining intact stretch of the historic, WPA limestone, step-stone revetment that once graced the entire Chicago lakefront.


For all these reasons and more, Promontory Point deserves your acknowledgement and designation as a Chicago landmark. We greatly appreciate your consideration of this request.

Promontory Point was built as landfill in Lake Michigan during the 1930's, with the assistance of the federal Works Progress Administration. Its landscape design was the work of renowned Chicago Park District architect Alfred Caldwell. The engineering of the limestone revetment, which once spanned the Chicago lakefront, is a unique solution to the problem of erosion and forms the transitional link between the natural power of Lake Michigan and the built environment of the city. Today, Promontory Point is home to the last stretch of intact, WPA-era limestone revetment along the lakefront.

Landmarks Illinois has advocated for the preservation of Promontory Point since it was included among the Ten Most Endangered Historic Places in Illinois in 2004, when the limestone revetment was threatened by plans to replace it with steel and concrete. Regrettably, that same threat now looms. Promontory Point is a treasured retreat for the Hyde Park community, the South Side, and the City of Chicago. Granting Chicago landmark designation to Promontory Point affirms that importance and supports a preservation approach for Promontory Point as endorsed by Mayor Lori Lightfoot and other elected representatives.
