Dear Mr. Laberge:

Thank you for requesting comments from our office concerning the possible effects of your project on cultural resources. Our comments are required by Section 106 of the National Historic Preservation Act of 1966, as amended, and its implementing regulations, 36 CFR 800: "Protection of Historic Properties". We concur that the property at 3217 E. 92nd Street is eligible for listing in the National Register of Historic Places.

Also, we concur that the proposal to demolish 3217 E. 92nd Street constitutes an adverse effect as defined in 36 CFR 800.5.

You should continue to work with this office to develop a plan to mitigate this adverse effect. Please note that the culvert must not be demolished prior to the resolution of the disposition of this historic property.


