The Department of Water Management require parts that work along with our tapping machines. Tapping machines are used to provide water service to the general public. The "B" machine boring bar is a necessary repair part to the tapping machine. These goods are necessary for our districts. Presently there is no contract for these goods. If the Bureau of Operations and Distribution do not have certain necessary materials to provide water to the general public or the fire department for hydrants this could become a public health and safety issue. Accordingly, the Department of Water Management is requesting emergency authorization for this purchase in the amount of \$3900.00.

Attached please find two quotations. Three quotes were requested but Alpha Specialty was unable to provide a quote. We are recommending Ziebell Water Service Products, Inc. as they were the lowest bidder.

I certify that this emergency poses a clear and imminent danger, requiring immediate procurement services, supplies or equipment to prevent or mitigate the loss or impairment of life, health, property, or essential public services and would not have been avoided by due care and diligence.
