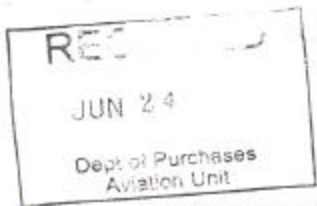

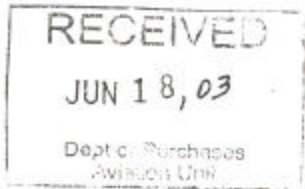

To City Chief Procurement Officer: Pursuant to 65ILCS5/8-10-24, of the Illinois Compiled Statues, please be advised of a request for Contract Modification on the above captioned project as follows:

DESCRIPTION:

The original project consisted of building out an existing space on the lower level of Concourse "B" for concessions storage. This modification consists of providing additional conduit and fluorescent utility fixtures for concessions storage at Midway Airport.

REASON:

One (1) card reader conduit, and one (1) spare conduit is needed for the dumpster enclosure. Also, additional lighting is needed because the Base Building Contractor did not supply lights, as originally agreed.
