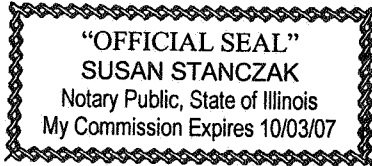

- Replace all damaged pipe supports.


