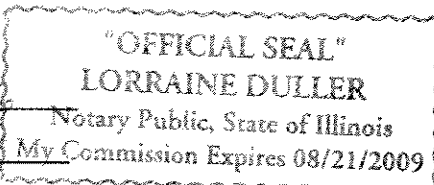

- The appropriate coating system shall be used (e.g. Sherwin Williams Coating Specification) for correct adhesion and longevity in the environment.
- Material removed shall be disposed of properly.
