

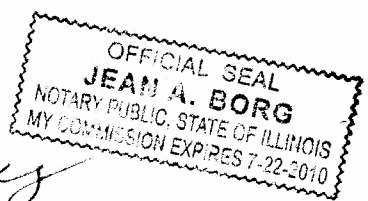

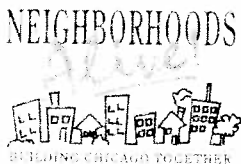

CDOT has been directed to install additional platform lighting at the Grand Blue Line CTA Station (CTA had a derailment near this location in September 2006). This is a demonstration of LED lighting, a new economic technology. The lighting will highlight the exit locations from the CTA platform. The light fixtures could not be performed by City Forces and are not covered by an existing term agreement.
