The scope of work to be performed under this sub-order includes but is not limited to; removal and replacement of signage, structure adjustment, bus pad installation, striping and removal and replacement of asphalt. Removal and replacement of the asphalt and applicable line items was removed from the original JOC proposal.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

Recently, the City was informed by IDOT that funding will be restricted to IDOT jurisdiction roadways only for the arterial street resurfacing program. Madison Street is under City jurisdiction within these limits. It was CDOT's intent to use the arterial street resurfacing program to resurface Madison Street. CDOT was also informed recently that City forces will not be able to install the proposed signage due to the size of the project. It makes sense to use the same JOC contractor that is performing the hardscape construction to resurface and install the proposed signage.
