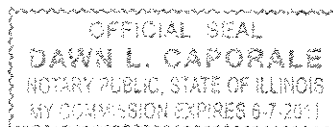



1. Please describe the major features of this project.

LaSalle Drive viaduct under Lake Shore Drive requires urgent structural repairs. The original scope of work includes removal of unsound concrete, replacing deteriorated reinforcement steel and concrete repairs to the main girders. The post tensioning system is in very poor condition and must be replaced to insure the safety and integrity of the structure. The additional work was not covered in the original scope and could not be anticipated at the beginning of the project.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The ongoing emergency repairs require specialized personnel and equipment. This work can not be performed by City Forces and is not covered by an existing term agreement. It would not be time or cost effective for us to perform the work through the City's traditional bid process.
