## 100,000 Homes Campaign Chicago: Housing Resources Committee

## Purpose:

The goal of the Housing Resources Committee is to secure housing and support services options for citizens of the Chicago communities being targeted by the campaign who are experiencing homelessness or are most vulnerable to it. Members of the committee will work to identify and discuss the various resources available to the campaign and will collaborate with agencies that represent potential housing and/or services resources. The Housing Resources Committee will ultimately establish connections between vulnerable citizens and homes and support.

## Tasks:

The Housing Resources Committee will perform the following tasks at meetings:

- Review potential housing and services resources for citizens experiencing homelessness and those most vulnerable who are named during Registry Week
- Analyze data to determine the targeted number of housing units so as to respond to data obtained through Registry Week surveys accordingly
- Collaborate with agencies that have housing units in order to obtain buy-in and unit setasides
- o Collaborate with agencies that have service supports in order to obtain buy-in and unit setasides
- o Create a model for Registry Week for how people will be identified during Registry Week
- o Create a model for how people will subsequently be housed and provided with support services
