The following information is provided in response to questions posed at our department's hearing on October 5, 2021 to discuss the proposed 2022 budget.

Alderman Reilly asked a number of questions in a memorandum to Acting Commissioner Meyer regarding Request for Information – 2022 Budget dated October 4, 2021.

The questions in the memorandum are listed below with corresponding responses.

1. Changes in headcount projected for 2022
  - a. Currently the department has 160 full time staff. One scheduled retirement and 12 possible new hires for the rest of 2021 puts the total count at 171. In 2022, the department has been budgeted 12 new positions, with an additional seven 2021 vacancies not yet filled carried over.
2. Number of funded vacancies and breakdown for 2022
  - a. Current vacancies (as of 10/6/21). This information is also available in the 2022 Department Budget Hearing Document book provided to aldermen.

3. Number of non-union employees scheduled to receive salary increases in the 2022 Budget
  - a. A total of 13 non-union employees are scheduled to receive salary increases in the 2022 Budget.
4. Description of outsourced services projected for 2022
  - a. As a department, BACP does not outsource a large volume of services. Based on past years, the department projects that it will outsource the following services:
    - i. Wheelchair accessibility vehicle dispatching service
    - ii. Various technology and IT suppliers (for laptops, camera equipment, and TV production hardware)
    - iii. Services to facilitate remote business education programming and expos
    - iv. Services for the Mayor's License Discipline Commissioner (Hearing Officers, court reporting)
    - v. Translation services
    - vi. Uniform supply
    - vii. Calibration of measurement devices for enforcement purposes
    - viii. Contracting of secret shoppers to inspect tobacco licensees for sales to minors violations
    - ix. Consulting and research services for special reports and projects
5. List of savings and cost-efficiencies due to zero-based budgeting
  - a. BACP worked closely with the Office of Budget and Management as part of the 2021 Budget to realize nearly \$1 M in savings from the Department's budget. As part of the 2022 Budget, BACP evaluated its post-pandemic needs, resulting in an incremental increase in the Department's Budget Recommendation due to added enforcement, equity-focused, and licensing staff.
6. List of businesses that received citations for COVID-related violations
  - a. A full list of businesses is attached in a separate spreadsheet, encompassing those that received COVID-related violations from the beginning of the pandemic through the end of September, 2021.
7. Number of inspections resulting in a Notice to Correct vs. all other violations (2019-2021 YTD)
  - a. 7,218 investigations resulted in a Notice to Correct. Some of these investigations also included other enforcement, combined with the Notice. 13,213 investigations resulted in the issuance of other enforcement without a Notice to Correct.
8. When a Notice to Correct is issued, how many follow up inspections result in a citation being issued vs. no violations found?
  - a. From 2019 through the end of September 2021, 3,660 follow up inspections were conducted on businesses that were originally issued a Notice. Of these, 1,666 investigations resulted in enforcement being issued, 760 were found to be in compliance, and the remaining resulted in no action due to lack of entry or the establishment being out of business. There were fewer follow up investigations (3,660) than initial investigations that resulted in a Notice (7,218) because 1) when a Notice is issued for failure to have obtained the proper license or permit, and the business subsequently obtains the proper license or permit, the Notice is automatically closed, and 2) some Notices are addressed during the course of

ongoing citywide investigation projects or subsequent resident complaints, and therefore are not considered “follow up” investigations but rather are resolved through other investigatory processes.

9. Total fines collected through liquor license pre-disciplinary hearings
  - a. A total of \$8,000 in fines were collected in this manner since 2019.

Alderman Reboyras asked for a list of companies that were not offering Paid Sick Leave.

Since 2019, BACP's Office of Labor Standards cited 12 businesses for not paying Paid Sick Leave to their employees, among hundreds of citations issued to businesses for violating other provisions of the Minimum Wage and Paid Sick Leave Ordinance. The department's 0140 line is \$153,396 for the 2022 Budget, divided between five vendors providing services to the City: 1) MB Real Estate Services, which provides property management services for the Food Truck Fest at Daley Plaza (\$31,191), 2) CDW-G, which provides technical assistance for the queue management system at the business and public vehicle licensing facilities (\$15,163), 3) the Illinois Department of Agriculture for calibration and repair services to ensure the accuracy of inspectional scales, as mandated by the State of Illinois (\$10,040), 4) Youth Outreach Services, which staffs underage secret shoppers for tobacco sales to minors investigations (\$21,660), 5) Language Line Solutions for all departmental translation services (\$7,000), and 6) Mayor's License Discipline Commission Hearing Officers (\$68,342).

BACP's 0143 Court Reporting Budget line is funded at \$5,600 in 2022.

The contracts for BACP's court reporting services are through the Department of Law, but include provisions for the companies to do work BACP. In 2021, BACP used BAREALTIME, LTD. The work done by this company is almost exclusively for the transcription of audio recordings from hearings before the Mayor's License Discipline Commission. BACP occasionally requests such transcripts for departmental use, or at the request of Department of Law attorneys or the Hearing Officers. Such transcript requests are more common for larger cases. When licensees' attorneys request a transcript, the licensees' attorneys pay BAREALTIME directly.

Alderman Vasquez asked for a breakdown of BACP's plan to spend and disperse ARP funding.

There are \$46 million in ARP funds in BACP's 2022 Budget, which fall into three primary buckets: 1) \$18 M from the total of \$51 M in the "Commercial corridors and responsive neighborhood activation investments" (page 6 of the American Rescue Plan Local Fiscal Recovery Fund Detail), 2) \$10 M from the "Food equity program" (page 2), and 3) \$18 M from the total of \$71 M in the "Targeted financial and legal assistance for underserved residents" (page 1) for a financial relief and capacity-building grant program for small nonprofit organizations.

Each of these programs will involve disbursing funds to contracted agencies to support businesses and entrepreneurs to build capacity, startup business concepts, and create programs and platforms to streamline how businesses and entrepreneurs interact with the City. As such, each will involve competitive RFP processes to select agencies capable of either offering direct services to businesses, or disbursing funds using standardized methodologies to businesses as end-recipients.

However, BACP is working to expand its investments in local chambers, including with significant investments in the new Chicago Business Center program (which funds the Centers at commensurate levels with cities like Portland) as well as further investments with Coronavirus Relief Funds this quarter and ARP funds allocated in the 2022 budget.

The following information is provided in response to questions posed at our department's hearing on October 5, 2021 to discuss the proposed 2022 budget.

Alderman Reilly requested information on where in the budgeted funding for rideshare administration could be found in the 2022 Budget recommendation.

The Department's Public Passenger Vehicle division regulates and licenses Transportation Network Providers (TNP) and chauffeurs. The personnel lines for this division are found on page 240 of the Budget Recommendations for Year 2022. Just over ten positions within this division work on TNP matters, including the Deputy Commissioner, Program Director, Program Analyst, Supervisor of Public Vehicle Inspections, and several administrative staff. This division also regulates other Public Passenger Vehicle types. Other BACP staff from other divisions including the Business Compliance Enforcement division and the Prosecutions and Adjudications division also work on TNP matters as they arise.
