Dear Chair Flores,

I am writing to you today to express my opposition to the planned development located at 4041, 4115 & 4147 West Ogden Avenue and 2309 South Keeler Avenue in my Ward.

Since April of 2023 members of my North Lawndale Economic Development Advisory Committee have been regularly meeting with the developer, IDI Logistics, 15 times in total. At the beginning of the process I made it very clear, along with the support of my Advisory Committee, that we would not support any development that would include transportation, distribution or logistics at this site. The committee members also expressed that they wanted to come to an agreement for community benefits before they would support a planned development at this location.

As currently written, the planned development for 4041, 4115 & 4147 West Ogden Avenue and 2309 South Keeler Avenue includes transportation, distribution and logistics as a use on this site by an unknown future tenant, despite the unanimous opposition of the Advisory Committee and myself. Moreover, despite attempts to find a mutually acceptable community benefits package, the developer, IDI, has still not come to an agreement with my advisory committee on what this package would consist of.

Since IDI has not been able to come to an agreement for any community benefits, nor has IDI listened to the North Lawndale Economic Advisory Committee in developing their plan for the site, I must state my opposition to this planned development and urge the Commission to reject this proposal.

I am writing as a resident of Little Village to express my opposition to the proposed plan to demolish several architecturally significant warehouses south of Ogden Ave. To keep it short, my reasons for this opposition include first and foremost a guaranteed increase in semi traffic, within a community which has already repeatedly been identified by the City itself as a neighborhood disproportionately bearing the brunt of industry and air pollution. This is an environmental justice issue, as the City has repeatedly expressed, and allowing this development would be in direct opposition to any path towards a cleaner future for this corridor.

Beyond that, allowing a massive distro center on this parcel will irreparably hamper any future possibility of creating a vibrant transit-oriented neighborhood the likes of which are models in the rest of the city. The area in questions has historically suffered from excessive auto traffic. These warehouses are directly near the CTA pink line stations, and could be converted to other adaptive re-uses including lofts and live-work spaces. Allowing this development will permanently hamper the residential desirability of the Ogden corridor, at the precise time as plans are being floated for a redesign of the street.


