

# Bike Chicago Application

Bike Chicago is offering residents free bikes and equipment to aid in lowering transportation costs and increasing mobility. By applying to this program you have the opportunity to receive a free bike, helmet, bike lock, front and rear lights, bike bell and bike chain lubricant.

## ELIGIBILITY

### Applicants must:

- Be a **Chicago Resident 14 and older**;
- AND have a **household income at or below 100% of the Area Median Income** for Chicago (see chart →)
- AND do not already own a bicycle;
- AND be a resident that **faces higher mobility hardship** (see map on next page);
- **OR Participate in CDOT mobility programing** (Green Corps, Learn to Ride, and/or Open Boulevards events)
