**PREPARE FOR TAXICAB MEDALLION LICENSE RENEWALS**  
**EVEN numbered taxicab medallion licenses expire February 29, 2016 and are scheduled to be renewed in January and February 2016.**

- 2.) BACP encourages all licensees to resolve outstanding debt before January 1, 2016.

- 3.) Taxicab Medallion License Renewal Fee is \$1,000 for a two year license term. Licensees WILL NOT pay the \$200 Accessibility (WAV) Fund fee at renewal. Instead, licensees will pay \$22/month towards the Accessibility (WAV) Fund at the same time they pay ground transportation taxes.
  
- 4.) Licensees should also check the status of their company in advance by visiting the Secretary of State's Web site Corporation/LLC Search/Certificate of Good Standing section at [www.cyberdriveillinois.com](http://www.cyberdriveillinois.com) .
  
- 5.) Taxicab medallion owners will not be required to submit a lease rate affidavit with license renewal paperwork.
