1. Please describe the major feature of this project.
This project is installing a new residential street lighting system in the 2th Ward on Richmond from Van Buren to Jackson. It's part of Aldermanic Menu Program. B.O.E. will supply davit poles and luminaires which City Lights will install. City Lights will supply helix foundations, piggyback fixtures, handholes, directional bore conduit, and supply all material and equipment needed. .

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner.
