 This project is a new residential street lighting project for a new development on Parnell from 87th to 84th. The Dept. of Planning and Development is funding the project. B.O.E. will supply davit poles, and piggyback fixtures which City Lights will install. City Lights will supply helix foundations, directional bore conduit, install handholes and supply all material and equipment needed.
