

This is the 19th project in the 2006 Mayor's Office new residential lighting program. In this program each Ward gets 2 blocks of lighting. This project is in the 2nd Ward on Lexington from California to Sacramento. B.O.E. will supply davit poles and luminaires which City Lights will install. City Lights will supply helix foundations, piggyback fixtures, handholes, directional bore conduit, and supply all material and equipment needed. .

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner. The Bureau of Electricity can't use the traditional bid process because of the time frame involved. The Bureau of Electricity established JOC to help us manage these situations when they occur.
