

This project is installing a new residential street lighting system in the 40<sup>th</sup> Ward on Whipple from Ardmore to Lincoln. It's part of the Aldermanic Menu Program. B.O.E. will supply davit poles and luminaires which City Lights will install. City Lights will supply helix foundations, piggyback fixtures, handholes, directional bore conduit, and supply all material and equipment needed. .
