Notice of public meeting to discuss the proposed application for a Special Use Application, filed by WCCC, LLC which would permit the licensing of an adult use cannabis dispensary for the property generally located at 923 West Weed Street, Chicago, Illinois ("Subject Property").

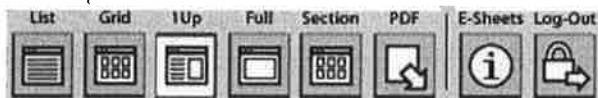
The Applicant is seeking a Special use, from the City of Chicago Zoning Board of Appeals (ZBA), which would allow for the establishment of an adult use cannabis dispensary located at the Subject Property.

The Subject Property is zoned C3-5, Commercial, Manufacturing, and Employment District and is in the 27<sup>th</sup> Ward and within the North District, under Section 17-7-100 (et seq.) of the Chicago Zoning Code. There are NO schools located within 500 feet of the Subject Property that would prevent it from operating an adult use (21 years or older) cannabis dispensary at the Subject Property.

You are invited to a Community meeting hosted by WCCC, LLC to discuss this application and the corresponding programming for the proposed new adult use cannabis dispensary, and to learn more about the Applicant and its existing cannabis operations.
