The following project was reviewed by the PRC:

1. **330 N. Wabash**  
(IBM Buildings – 42<sup>nd</sup> Ward)

Proposal: Proposed design of a previously approved entry canopy and metal curtain for the ground floor hotel lobby.

Action: Approved unanimously with the following conditions:

1. As proposed, the canopy shall be no greater than 21'- 3 1/2" in depth, 24'-7" in width and 2' in thickness;
2. Signage details shall be submitted for staff review and approval with the sign permit application; and,
3. There was concern raised at the meeting regarding the exposed light bulbs under the canopy as well as the overall light levels and the illumination color used on the first floor (main lobby, hotel lobby, porte cochere) of the building. Your team confirmed that the illumination color on the first floor would be consistent (i.e. all cool or all warm) and the lighting levels would be balanced across the spaces, as per recent discussions with management. The Committee agreed that a mock-up of the underside of the canopy would be helpful to determine if the bulbs should be partially concealed and/or the lighting should be dimmable. Please contact staff to review the mock-up and final design of the canopy lighting.
