2. Preliminary Landmark Recommendation

(Former) JAMES MULLIGAN PUBLIC SCHOOL BUILDING WARD 43
1855-1863 N. Sheffield Ave.

Alderman Smith spoke in support of the designation. Vote to approve the resolution to recommend preliminary landmark designation for the **(Former) JAMES MULLIGAN PUBLIC SCHOOL BUILDING** and to initiate the consideration process for possible designation of the building as a Chicago Landmark.

Motioned by Dziekiewicz, seconded by Blanchard. Approved unanimously. (6-0)

Vote to approve the resolution to certify that the project has been substantially completed in accordance with the approved ordinance and meets the eligibility requirements for the Class L incentive for the building at **30 N. Michigan Ave.** in the **HISTORIC MICHIGAN BOULEVARD DISTRICT.**

PERMIT REVIEW COMMITTEE REPORT TO
COMMISSION ON CHICAGO LANDMARKS

November 7, 2013

The Permit Review Committee (PRC) met on October 3, 2013, at 1:30 p.m. The meeting was held at 121 N. LaSalle St., in Room 201-A.

The following projects were reviewed by the PRC:

1. **226 W. St. Paul**
(Old Town Triangle District – 43rd Ward)

Proposal: Proposed rehabilitation of two-unit residential building into a single-family residence including front entry modifications and construction of two new dormers.

Action: Approved unanimously with the following conditions:

1. Permit plans for the proposed changes to the front entrance shall include dimensioned details of the transom window, door and trim; and,
2. The proposed dormer shall be sided with materials compatible with wood siding of the building and also the color of the asphalt shingles to further minimize visibility.

2. **2129 N. Sedgwick**
(Mid-North District – 43rd Ward)

Proposal: Proposed exterior and interior rehabilitation including a 3-story rear addition to a historic 2-story single-family residence.

Action: Approved unanimously with the following conditions:

1. The three story rear addition as shown on drawings dated August 26, 2013, is approved;

2. Window details, cornice repair details, front door and surround details, and front stair and railing details shall be included with the permit plans;
3. Documentation/photos of existing conditions of the historic side bay as well as repair/replacement details shall be included with the permit plans;
4. Material samples of the new and any replacement masonry and the proposed cementitious plank rain screen cladding shall be review and approved with the permit application;
5. A report by a licensed structural engineer addressing how the historic facades and roof to remain should be supported, braced and protected, in-situ, during the demolition of the exterior portions of the building and the interior structure and the excavation and construction of the new addition as well as during the foundation work, shall be included on the permit plans. The recommended measures, sequencing, and protections shall be incorporated in the structural and architectural drawings; and,
6. The project requires a zoning variation and/or adjustment, and the Commission takes no position regarding any requested variance/adjustment relative to the zoning code requirements.

3. **637 S. Dearborn**
(Printing House Row District – 4th Ward)

Proposal: Proposed installation of 12’-long x 9’-9”-tall non-illuminated vinyl wall sign for “Grace Episcopal Church of Chicago” on the north façade of the building.

Action: Approved unanimously as submitted.

4. **852 N. Wolcott**
(East Village District – 1st Ward)

Proposal: Proposed construction of two new dormers on a 1 ½-story single-family residence.

Action: Approved unanimously with the following condition:

1. As proposed, dormer siding shall be wood clapboard with a 6” lap exposure. Details of the proposed siding shall be reviewed and approved by Historic Preservation staff as part of the permit application.

5. **1501-03 N. Milwaukee**
(Milwaukee Avenue District – 1st Ward)

Proposal: Proposed demolition of a 2-story frame building.

Action: The Committee reviewed the pre-permit application based on Article III of the Commission’s *Rules and Regulations*, which includes “Criteria for Determining a Contributing Building within a Landmark District”. At the meeting, the Committee unanimously adopted the following findings:

(A) Find that, pursuant to the Milwaukee Avenue District Designation Ordinance designating the Milwaukee Avenue District a Chicago Landmark on April 9, 2008, for permits for demolition only, the significant historical and architectural features of the district are identified as all exterior elevations and roofs, regardless of visibility from public rights-of-way; and,

(B) Preliminarily find that the subject building, a 2-story frame building constructed in 1881, contributes to the character of the Milwaukee Avenue District, which includes commercial buildings in a wide variety of architectural styles built in the late nineteenth and early twentieth centuries; and,

(C) Preliminarily find that the demolition of a contributing building or structure within a landmark district is a *per se* adverse effect on the significant historical and architectural features, pursuant to Article III, Section G.3.b., of the *Rules and Regulations*; and,

(D) Pursuant to Section 2-120-780 of the Landmarks Ordinance, preliminarily find that the demolition of the subject property will adversely affect and destroy significant historical and architectural features of the property and the district.

Should Historic Preservation staff receive a wrecking application for the subject building, staff shall issue a preliminary disapproval of the application. A preliminary disapproval of the application would trigger an informal conference and, if the informal conference does not reach an accord, a public hearing on the permit application would be scheduled in accordance with the provisions of the Chicago Landmarks Ordinance.

6. **1505 N. Milwaukee**
(Milwaukee Avenue District – 1st Ward)

Proposal: Proposed new construction of a 4-story masonry commercial and residential building.

Action: Approved unanimously with the following conditions:

1. The masonry façade design shall be modified to provide a more substantial coping or cornice at the parapet, and lintels and sills shall be incorporated at the masonry openings to be more compatible with the architectural character of the historic properties of the district;
2. The proposed canted metal surround of the storefront shall be eliminated, and the storefront glazing shall extend to the perimeter of the opening, typical of proportions and arrangement of historic storefronts in the district. Recesses in the storefront shall be limited to entries only. The storefront design shall incorporate a 1'-2'-tall masonry or metal-paneled knee wall below the display windows. Enlarged details of the storefront system shall be included in the permit plans; and,
3. Exterior wall material samples reviewed at the Committee meeting are approved as proposed. The exposed masonry wall on the north (side) from the 3rd-floor to the parapet shall be clad with face brick to match the (front) Milwaukee Avenue façade.
