**7. Preliminary Decision on Permit Application for Demolition Pursuant to §2-120-740 through §2-120-825 of the Municipal Code**

Commissioner Reifman left the meeting

Emily Barton presented the staff's recommendation that the Commission: (A) Find that, pursuant to Article III, Section G.1. of the Rules and Regulations of the Commission on Chicago Landmarks (the "Rules and Regulations"), that the significant historical or architectural features of the district are all exterior elevations and rooflines; and (B) Preliminarily find that the subject building, a 2-story masonry, commercial building constructed prior to 1911, with 2-story addition constructed before 1950; contributes to the character of the Motor Row District, which provides an excellent illustration of the early development of the American automobile industry and features the largest intact collection of early automobile dealerships and related businesses in the United States; and (C) Preliminarily find that the demolition of a contributing building or structure within a landmark district is a per se adverse effect on the significant historical and architectural features, pursuant to Article III, Section G.3.b., of the Rules and Regulations; and (D) Pursuant to Section 2-120-780 of the Landmarks Ordinance, preliminarily find that the demolition of the subject property will adversely affect and destroy significant historical and architectural features of the property and the district; and (E) Issue a preliminary decision disapproving the demolition application.

Dijana Cuvalo informed the Commission that a preliminary decision disapproving the demolition application would trigger an informal conference and, if the informal conference does not reach an accord, a public hearing on the permit application would be scheduled in accordance with the provisions of the Chicago Landmarks Ordinance.

**Motioned by Wong, seconded by Moreno. Approved (5-1).**

# MEETING MINUTES

## PERMIT REVIEW COMMITTEE COMMISSION ON CHICAGO LANDMARKS

The Permit Review Committee (PRC) met on August 2, 2018, at 3:30 p.m. The meeting was held at 121 N. LaSalle St., in Room 201-A.

The following projects were reviewed by the PRC:

**1. 111 N. State 42<sup>nd</sup> Ward  
Marshall Field and Company Building**

Proposed exterior alterations including new office entrance and canopies, new rooftop addition and amenity deck, and interior rehabilitation.

**Action:** Approved unanimously with the following conditions:

1. New dedicated office entrance on the south façade is approved as proposed. Storefront and door details shall be submitted with the permit plans;
2. The two proposed metal canopies at the new office entrance are approved as proposed. Canopy details to be submitted as part of the permit application;
3. Exterior signage is not approved at this time. Details of signage to be submitted for Historic Preservation staff review and approval when available;
4. All interior changes including those regarding the new office lobby and relocation of the fountain are approved as proposed. Details of the new sliding partitions and redesigned retail pads and fixtures shall be included with the permit plans; and,
5. As proposed, the rooftop deck glass railings shall be set back 5' from the inner face of the parapet along State Street and Washington Street, and 10' from the inner face of the parapet along Wabash Avenue. The roof trellis shall be set back 30' from the inner face of the western parapet. Details of railings shall be included with the

permit plans. All vegetation should be low growth with no trees or tall shrubs.

**2. 530 W. Fullerton** **43<sup>rd</sup> Ward**  
**Mid-North District**

Proposed installation of a new accessible ramp and entrance canopy at the front of the church.

**Action:** Approved unanimously with the following conditions:

1. The ramp and entrance canopy are approved as proposed; and,
2. Historic Preservation staff shall be notified to review for approval limestone cladding samples on-site prior to order and installation.

**3. 714 S. Dearborn** **4<sup>th</sup> Ward**  
**Printing House Row District**

Proposed exterior and interior renovation of non-historic rooftop dwelling including new deck.

**Action:** Approved unanimously with the following conditions:

1. At the north elevation of the rooftop addition's west wing, the lower-level wall enclosing additional square footage be set back 1' and the upper-level balcony be set back 3'; from the west elevation of the west wing to eliminate visibility above the Federal Street cornice of 714 South Dearborn Street;
2. A transparent or more open design guardrail be employed at all visible locations, such as a glass or simple open, metal guardrail, to minimize its visual impact and prevent the appearance of a larger overall rooftop mass;
3. The portion of the wall below the glass window wall at the central wing's north elevation and all trim to be a dark grey to ensure that all of this highly visible elevation recedes as much as possible; and,
4. Roofing/cladding samples be submitted for staff review and approval with the permit application.

**4. 465 W. Cermak** **11<sup>th</sup> Ward**  
**Cermak Road Bridge District**

Proposed retail conversion of an industrial building including partial window repair and replacement, graffiti removal, new first floor east elevation entrance stairs and accessible ramp and new metal canopies.

**Action:** Approved unanimously with the following conditions:

1. The new windows shall match the historic windows in size, glass size, operation, muntin arrangement, and muntin size. The windows can be simulated divide lite windows as proposed. Existing and proposed details of exterior profiles shall be submitted with the permit application;

2. The existing CMU infill to remain may be painted as proposed, but the color shall match the existing historic face brick subject to on-site staff review and approval;
3. The proposed stair, ramp, and planter system is approved as proposed, but the cladding shall match the color and texture of the historic limestone on the building subject to staff review and approval of a sample;
4. The proposed entrance doors and storefronts are approved as submitted subject to staff review and approval of the permit plans, which shall include elevations, sections, and enlarged dimensioned details. All storefront elements shall have a dark factory-applied finish and all glass shall be clear vision glass;
5. The proposed metal canopies are approved as submitted subject to staff review and approval of enlarged dimensioned details and attachment details. All canopies shall have a dark, factory-applied finish and all glass shall be clear vision;
6. The proposed large canopy shall be revised to be located inside the masonry columns rather than overlapping the columns as shown;
7. Any signage, including any exterior lighting, shall be permitted separately and reviewed and approved by Historic Preservation staff prior to order and installation; and,
8. As proposed the masonry façade may be cleaned. The applicants shall provide any chemical cleaning product specifications and material safety data sheets with the environmental cleaning application. Any pressure washing shall not exceed 400 psi. Staff shall be notified to view and approve test cleaning areas.
