Emily Barton presented the staff's recommendation that the Commission: (A) Preliminarily find that, pursuant to Article III, Section G.1. of the Rules and Regulations of the Commission on Chicago Landmarks (the "Rules and Regulations"), the significant historical or architectural features of the Nordine-Perkins House are all exterior elevations, including rooflines; and (B) Preliminarily find that the demolition of the Nordine-Perkins House, a proposed landmark, is contrary to the criteria of Article III, Section G.3.a of the Rules and Regulations and, per Section G.3.b, is a per se adverse effect on the significant historical and architectural features; and (C) Issue a preliminary decision disapproving the demolition application.

Ms. Barton informed the Commission that a preliminary decision disapproving the demolition application would trigger an expedited consideration of the proposed designation and permit application. Pursuant to Section 2-120-820, the Commission must schedule and conduct a public hearing on both the proposed designation and the application for a demolition permit and must notify the City Council of its recommendation within 90 days.

Proposed addition of rooftop dormers to the rear of existing dormers, and replacement of wood front porch and door.
