The Permit Review Committee (PRC) met on January 8, 2015, at 12:54 p.m. The meeting was held at 121 N. LaSalle St., in Room 1003A

The following projects were reviewed by the PRC:

#### 1. 948-954 W. Fulton Market

27<sup>th</sup> Ward

#### **Proposed Fulton-Randolph Market District**

Proposed one-story rooftop addition, outdoor deck, cabanas and metal screen.

**Action:** Approved unanimously (vote was 3-0 with Commissioner Wong recusing) with the following conditions:

- 1. The location, scale, size, design and materials of the proposed rooftop addition approved as shown on plans dated December 12, 2014. As proposed, the color of the various materials should be generally uniform; and,
- 2. As proposed, plantings shall be low growth with no tall shrubs or trees.

### 2. 830 – 1200 West Fulton Market Streetscape Proposed Fulton-Randolph Market District

27<sup>th</sup> Ward

Proposed geometric (grading, sidewalk elevations, etc.) changes to Fulton Market Street from Green Street to Racine Street.

**Action:** The Committee adopted unanimously (vote was 3-0 with Commissioner

Wong recusing) the following findings:

- I. Preliminarily adopted, for the purposes of permit review, the 'Streetscape' section of the Fulton-Randolph Market District Design Guidelines (draft dated November 21, 2014);
- II. Found that the conceptual modifications to street geometry, grading and the ground plane for Fulton Market Street within the boundary of the proposed district, with the following conditions, meet the criteria set forth in the Commission's Rules and Regulations, the Commission's *Guidelines for Alterations to Historic Buildings and New Construction*, the *U.S. Secretary of the Interior's Standards for Rehabilitation of Historic Buildings*, and the *draft Fulton-Randolph Market District Guidelines* and therefore, the project will not have an adverse effect on the significant historical and architectural features of the proposed landmark district and approved the project with the following conditions:
  - 1. As proposed, the raised sidewalk loading docks in all existing locations shall be maintained, repaired or rebuilt to current elevations but modified as needed to provide accessibility. Enlarged plans of all individual raised sidewalk locations with proposed modifications as well as key elevations showing railings, which should maintain an industrial aesthetic that is transparent and minimal in design to allow for views to the adjacent building façade, shall be submitted for Committee review and approval as part of the next submittal and prior to installation;
  - 2. Enlarged plans and elevations of all proposed bumpout locations, including proposed paving materials, should be submitted for Committee review and approval as part of the next submittal and prior to installation;
  - 3. Enlarged plans and sections of the four raised intersections, including proposed materials, should be submitted for Committee review and approval as part of the next submittal and prior to installation;
  - 4. Paving patterns and colors have a significant impact on the historic character of the proposed district and should be compatible with the historic district. Historically, Belgian-block paving was prevalent throughout the area (currently it is visible in certain sections of alleys) and paving of a pattern and color consistent with the historic block paving is recommended. Further details and material samples should be provided for the Committee review and approval as part of the next submittal and prior to installation;
  - 5. The existing significant features (sidewalks, reduced-height street-level sidewalks, raised sidewalk loading docks, etc.) on side streets, to the extent that they will be included in the streetscape scope of work, shall be maintained. Proposed plans showing modifications to side street geometry, grading and the ground plane as well as enlarged plans and key elevations of proposed raised sidewalk loading dock conditions shall be submitted for Committee review and approval as part of the next submittal and prior to installation;
  - 6. As proposed and as the project develops, additional elements of the streetscape, including elements such as railings, bollards/vertical identifiers/signs, street lighting, and landscaping, etc., will be

- presented to the Committee for review and a decision at a future meeting; and,
- 7. The Department of Transportation, in coordination with the Department of Planning and Development, shall reach out to and meet with all property owners impacted by the streetscape project prior to the next project presentation to the Committee.

# 3. 410 W. Webster 43<sup>rd</sup> Ward Mid-North District

Proposed new 1-story rear addition for 1-car garage, stair, and rooftop deck to existing 2-story townhouse.

**Action:** Approved unanimously with the following conditions:

- 1. As proposed, the common brick proposed for the rear addition shall match the common brick of the west façade of the townhouse in size, profile, color, and texture and the new mortar shall match the mortar of the townhouse in color and joint profile;
- 2. The downspout, proposed to be installed on the west façade of the historic building, shall be relocated to be attached to the rear addition instead;
- 3. Cut-sheets of the garage door, proposed to incorporate recessed paneling, and the man door shall be provided as part of the permit application; and,
- 4. The project as proposed would require a zoning adjustment/variation to reduce the side yard setback. The Commission takes no position regarding any requested variance/adjustment relative to the zoning code requirements.

#### 4. 4858 S. Kenwood (The Blossom House) Kenwood District

4<sup>th</sup> Ward

Proposed exterior and interior rehabilitation of single-family residence including repair and reconstruction of deteriorated porches, a new 1-story rear addition, a new fence in the rear yard, and repairs to the carriage house.

**Action:** Approved unanimously with the following conditions:

#### Main House:

- 1. As proposed, the two deteriorated historic open porches may be dismantled and rebuilt to match the historic design. Any columns and railings that can be salvaged shall be reused and those that are beyond repair shall be replicated in-kind as proposed;
- 2. Areas of spot in-kind replacement of the wood siding shall be confirmed by Historic Preservation staff prior to work occurring;
- 3. The top of the new fence proposed in the rear yard may be no taller than 6' from grade and may be constructed of painted or stained wood or open metal. The fence shall not be attached to the house or carriage house and a gap of at least 2" shall be provided. Elevation drawings shall be included in the permit plans;
- 4. The new rear 1-story addition and raised deck is approved as proposed;

#### Carriage House:

- 5. The new overhead sectional, motorized garage door shall replicate the original carriage doors in design as proposed. Enlarged details shall be included in the permit plans;
- 6. Replacement roofing and framing may be installed as necessary and new gutters and downspouts shall match the historic profiles and shapes. Enlarged details shall be included in the permit plans; and,

### Sample Review:

7. All new mortar shall match historic mortar in size, profile, texture, and type/strength. Any new bricks shall match the historic roman bricks in size, color, texture, and finish. Any new limestone shall match the historic limestone in shape, color, texture, and finish. Samples shall be reviewed and approved by Historic Preservation staff prior to order and installation.
