ORDINANCE O2021-3921 SUMMARY

The goal of ordinance O2021-3921 is to establish a procedure for the City Council to engage in the budget process. Alderman Vasquez has submitted preliminary versions of three pieces of core legislation that make up our Municipal budget: The Appropriations Ordinance, the Revenue Ordinance, and the Management Ordinance.

The intent is to present measures well in advance to ensure that the City Council is prepared and has the tools to pass a budget that serves the needs of the people of Chicago. This document is a tool to achieve the end result.



ORDINANCE O2021-3921 FISCAL IMPACT

- Impact is a \$1,989,146,478 above the Mayor's proposed 2022 recommendation
 - 2022 Mayor's Recommendation is \$12,079,536,000
 - 2022 Independent Budget Recommendation is \$14,068,682,478
 - Independent Budget Recommendation does not include Department 062
 - Proposed Independent recommendation focuses heavily on investing in Social Services (Public Health, People with Disabilities, Family and Support Services and Transportation.
