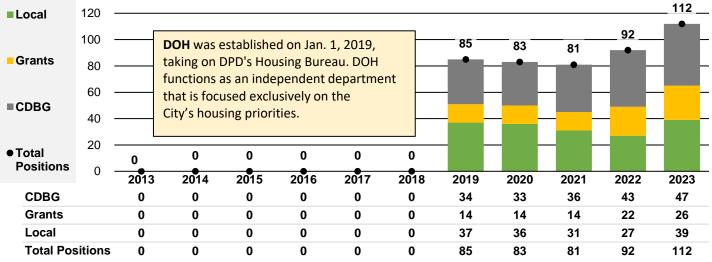
- The 2023 Budget Recommendation appropriates \$323.8 million to DOH, which is a decrease of \$104.8 million, or (24.4%), from the revised FY22 budget.
- The appropriation categories driving the FY23 decrease are Housing Assistance and Contractual Services, which are decreasing by \$127.7 million and \$13.15 million, respectively, from the revised FY22 budget.
- The Department receives a majority of its funding from the Grants (59.6%) and CDBGs (26.6%) in FY23.
- The proposed FY23 Budget appropriates **112 positions** to the department, which is 20 positions more than FY22.
- \blacktriangleright COFA estimates DOH's vacancy rate to be 7.6% as of Oct 2022.

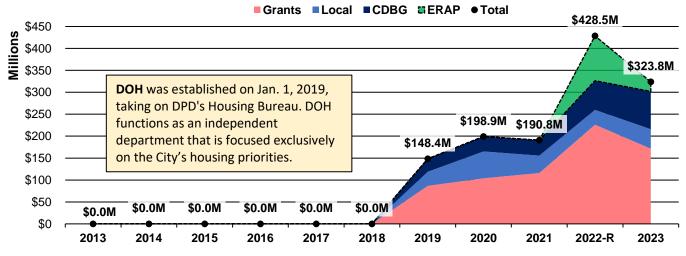
