

- The 2023 Budget Recommendation appropriates \$3.17 million to the Commission, which is an increase of \$0.22 million, or 7.5%.
- > The appropriation category driving the FY23 increase is Personnel Services, which is increasing by \$0.2 million, or 10.6%, from FY22.
- Personnel accounts for 73.3% of the Commissions FY23 budget.
- > The Commission receives a majority of its funding—61.6%—from **CDBGs** in FY23. The remaining 38.4% of funding comes from the Corporate Fund.
- > The proposed FY23 Budget appropriates **20 positions** to the Commission, which is an increase of 1 position from FY22.
- COFA estimates the vacancy rate to be 26.3% as of Oct 2022.




