
Amounts in Thousands

- ➤ The 2023 Budget Recommendation appropriates \$1,202 million to the Department of Aviation (CDA), which is an increase of \$132.8 million, or 12.4%, from FY22's revised budget.
- ➤ The appropriation category driving the FY23 increase is Contractual Services, which is increasing by **\$123.2 million**, or 14.5%, from the revised FY22 budget.
- ➤ A majority of CDA's funding in FY23—55.2%—comes from the **Enterprise Funds** the Chicago Midway & O'Hare Airport Funds.
- From a Program Area standpoint, *Capital Development*—which provides engineering and architectural services for airport development projects—is appropriated **\$463.7 million** in the FY23 budget.
- ➤ The proposed FY23 Budget appropriates **2,157 FTEs** to CDA, which is an increase of 69 FTEs compared to FY22.
- ➤ The program areas which have the most FTEs budgeted for FY23 are *Airfield Operations* and *Security & Safety Management*, which are budgeted 673 and 603 FTEs in FY23, respectively.


