### News & Updates

The CDC recently issued a Health Advisory¹ reminding clinicians on the importance of prompt antiviral treatment in patients with influenza and to continue influenza and to continue influenza vaccination efforts. Vaccination is the best way to protect against influenza infection and all Chicagoans six months and older are encouraged to get vaccinated. Chicagoans should ask their healthcare provider or pharmacist about vaccine availability. To locate the closest City of Chicago clinic or retail pharmacy, go to www.chicagoflushots.org. Uninsured or underinsured adults and children 0-18 years old who are uninsured, underinsured, or Medicaid (Title XIX) insured can visit any CDPH Walk-in Immunization Clinic² to receive the flu vaccine.

#### What is the risk?

Currently, the risk of influenza infection is high.

# Are severe cases of influenza occurring? For the week of January 19-25, 2020, 30 influenzaassociated ICU hospitalizations were reported


associated ICU hospitalizations were reported (**Figure 1**).

Since September 29, 2019, 150 influenza-associated ICU hospitalizations have been reported; 91 (61%) were positive for influenza A (5 H3N2, 24 H1N1<sub>pdm09</sub>, 62 unknown subtype [subtyping not performed or not all subtypes tested]) and 59 (39%) were positive for influenza B. The median age of influenza A cases is 57 years and the median age of influenza B cases is 32 years (overall range of 1 month-96 years); one pediatric death was reported and eight cases were admitted from long-term care facilities; selected attributes are summarized in **Table 1**.





Figure 2. Percent of specimens testing positive (by RT-PCR) for influenza by subtype as reported by local laboratories serving Chicago hospitals, for the current season (2019-2020) October-May 40



## Which influenza strains are circulating?

Data on influenza virus test results are reported by

Chicago laboratories performing influenza RT-PCR. For the week of January 19-25, 2020, 406 of the 1,748 (23%) specimens tested for influenza were positive; 239 typed as influenza A (2 H3N2, 77 H1N1pdm09, and 160 unknown subtype [subtyping not performed or not all subtypes tested]) and 167 typed as influenza B (**Figure 2**).

Since September 29, 2019, 1,985 of 18,100 (11.0%) specimens tested for influenza have been positive; 825 (42%) typed as influenza A (32 H3N2, 233 H1N1pdm09, and 560 unknown subtype [subtyping not performed or not all subtypes tested]) and 1,160 (58%) typed as influenza B. The cumulative number of specimens testing positive for influenza so far this season is higher than last season (5.1%) but lower than 2017-2018 (16.6%) for the same time period.  $^{\$}$

How much influenza-like illness is occurring?

Several outpatient clinics throughout Chicago participate in CDC's Influenza-like Illness Surveillance Network (ILINet) by reporting on a weekly basis the total number of outpatient clinic visits, and of those visits. the number with influenza-like illness (ILI). For the week of January 19-25, 2020, 207 of the 5,778 (3.6%) reported outpatient clinic visits were due to influenzalike illness, which is lower than Illinois at 5.6% (Figure 3).




Figure 4. Percent of emergency department visits attributed to influenza-like illness for Chicago zip codes based on chief complaint data submitted to **ESSENCE**, Chicago, by week, for the current

In addition to ILINet, ESSENCE is an electronic syndromic surveillance system that utilizes the chief complaints of patients visiting emergency departments to monitor for influenza-like illness. Currently, ESSENCE captures nearly every emergency department visit in the city on a daily basis. For the week of January 19-25, 2020, 1,594 of the 25,590 (6.2%) total emergency department visits were due to influenza-like illness (Figure 4).

**Figure 5** represents the percentage of emergency department visits due to influenza-like illness aggregated by patient zip code. For the week of January 19-25, 2020, 49 of 59 (83%) zip codes had moderate to high ILI activity levels; this is higher than last season where 64% of zip codes were at moderate to high levels for the same time period and the eighth consecutive week where over half of zip codes had moderate to high ILI activity levels.

### Where can I get more information?

The Centers for Disease Control and Prevention's FluView<sup>3</sup> report provides national updates and trends related to the intensity of influenza activity across the United States, as well as detailed information on antiviral resistance, severity of illness, and other topics. ### **Reporting Information**

Illinois Department of Public Health recently issued Influenza Testing and Reporting Guidance<sup>7</sup>. The Chicago Department of Public Health has previously issued guidance on reporting influenza-associated ICU hospitalizations<sup>8</sup>. Healthcare facilities can report cases to the Chicago Department of Public Health via the Illinois National Electronic Disease Surveillance System (INEDSS)<sup>9</sup>. 


Figure 5. Influenza-like Illness (ILI) activity level by patient zip code determined by chief complaint data submitted to ESSENCE, Chicago, for week of January 19-25, 2020 (Week 4)
