#### What is the risk?

Currently, the risk of influenza infection is low.

# Are severe cases of influenza occurring? For the week of November 17-23, 2019, one influenza-associated ICU hospitalization was reported.




Figure 1. Number of influenza-associated ICU hospitalizations reported for Chicago residents, for the current season (2019-2020) and previous season (2018-2019), October-May.

Since September 29, 2019, six influenza-associated ICU hospitalizations have been reported; all were positive for influenza A (2 H3N2, 2 H1N1pdm09, 2 unknown subtype [subtyping not performed or not all subtypes tested]) (**Figure 1**).

#### Which influenza strains are circulating?





Figure 2. Percent of specimens testing positive (by RT-PCR) for influenza by subtype as reported by local laboratories serving

Data on influenza virus test results are reported by Chicago laboratories performing influenza RT-PCR. For the week of November 17-23, 2019, 17 of the 835 (2.0%) specimens tested for influenza were positive; 10 typed as influenza A (1 H3N2, 2 H1N1pdm09, and 7 unknown subtype [subtyping not performed or not all subtypes tested]) and 7 typed as influenza B (**Figure 2**).

Since September 29, 2019, 47 of 6,223 (<1%) specimens tested for influenza have been positive; 24 typed as influenza A (9 H3N2, 4 H1N1pdm09, and 11 unknown subtype [subtyping not performed or not all subtypes tested]) and 23 typed as influenza B. The cumulative percent of specimens testing positive for influenza is similar to previous seasons during the same time period (**Figure 3**)

### How much influenza-like illness is occurring?

Several outpatient clinics throughout Chicago participate in CDC's Influenza-like Illness Surveillance Network (ILINet) by reporting on a weekly basis the total number of outpatient clinic visits, and of those visits, the number with influenza-like illness (ILI). For the week of November 17-23, 2019, 110 of the 5,916 (1.9%) reported outpatient clinic visits were due to influenza-like illness, which is similar to Illinois at 2.1% (**Figure 4**).




Figure 5. Percent of **emergency department** visits attributed to influenza-like illness for Chicago zip codes based on chief complaint data submitted to **ESSENCE**, Chicago, by week, for the current

In addition to ILINet, ESSENCE is an electronic syndromic surveillance system that utilizes the chief complaints of patients visiting emergency departments to monitor for influenza-like illness. Currently, ESSENCE captures nearly every emergency department visit in the city on a daily basis. For the week of November 17-23, 2019, 456 of the 23,768 (1.9%) total emergency department visits were due to influenza-like illness (**Figure 5**).





Figure 6. Influenza-like Illness (ILI) activity level by patient zip code determined by chief complaint data submitted to **ESSENCE**, Chicago, for week of November 17-23, 2019 (Week 47).

Figure 6 represents the percentage of emergency department visits due to influenza-like illness aggregated by patient zip code. For the week of November 17-23, 2019, 17 of 59 (29%) zip codes had moderate to high ILI activity levels; this is lower than last season where 41% of zip codes were at moderate to high levels for the same time period.

#### Where can I get more information?

The Centers for Disease Control and Prevention's FluView<sup>2</sup> report provides national updates and trends related to the intensity of influenza activity across the United States, as well as detailed information on antiviral resistance, severity of illness, and other topics. #### **Reporting Information**

Illinois Department of Public Health recently issued Influenza Testing and Reporting Guidance<sup>6</sup>. The Chicago Department of Public Health has previously issued guidance on reporting influenza-associated ICU hospitalizations<sup>7</sup>. Healthcare facilities can report cases to the Chicago Department of Public Health via the Illinois National Electronic Disease Surveillance System (INEDSS)<sup>8</sup>.
