DECISION-MAKING PROCESS



The Policy Working Group will reach consensus using the Fist to Five* method.

*A fist means, "I object and will block consensus (usually on moral grounds)." One finger means, "I'll just barely go along." or, "I don't like this but it's not quite a no." or, "I think there is lots more work to do on this proposal." Two fingers means "I don't much like this but I'll go along." Three fingers means, "I'm in the middle somewhere. Like some of it, but not all." Four fingers means, "This is fine." Five fingers means, "I like this a lot, I think it's the best possible decision."
