We have to 4 get your definition of respect, Mr. Carney, but, 5 first of all, I have to get this thing to come back 6 on. 7 Mr. Wysinger, Assistant Superintendent Wysinger, if that's your title if I'm correct, where 8 9 is Superintendent McCarthy? 10 I spoke to someone in his office at 3:30 and I was informed that he is in Chicago today. 11 12 He's in the office. 13 Mr. Bazarek, do you know 14 where -- is there an explanation for why the 15 Superintendent is not here tonight? 16 MR. CARNEY: Continue, Mr. More. MR. MORE: Mr. Carney, why do you -- why don't 17 18 you let them answer the question and let the public 19 see that there is a question to be answered? 20 MR. CARNEY: Because it's our meeting and I'm 21 running the meeting. 22 MR. MORE: So that's hearsay and you have control over the true minutes? 23 24 MR. CARNEY: I do. Continue.

MR. MORE: And that is not -- that does not let 1 2 me enjoy my First Amendment rights. 3 MR. CARNEY: Continue, Mr. More. 4 MR. MORE: You have control over the content of 5 my conveyances? What authority do you cite to support that position? 6 7 MR. CARNEY: Continue, Mr. More. MR. MORE: Okay. Under my objection, I don't 8 consent to this. 9 First of all, I have to get this off my conscious. I do not consent to have anything as a citizen of the City of Chicago presented to the City 13 of Chicago Police Department from the Anti-Defamation League. There are references to training materials from the ADL. It is my understanding that that's the Anti-Defamation League. Is that correct, Mr. Bazarek? 19 What does the ADL stand for? I don't consent to anything from the Anti-Defamation League. The Anti-Defamation League is committed to getting rid of people like me at any cost. 23 Number two, I don't consent to have any 24 arrangement in the City of Chicago as a citizen of

1 the City of Chicago in which there is any 2 provocation of grave sins against the Sixth and 3 Ninth Commandments under the auspices of stopping 4 prostitution. 5 There is not a legitimate way to prevent prostitution by having employees of the City of 6 7 Chicago who are dressed in a way that's not 8 compatible with the requirements of modesty of 9 dress. I don't consent to that. 10 Next question to the Assistant 11 Superintendent speaking for the City of Chicago: 12 The People vs. Clark and the People vs. Moreno, the 13 Illinois Supreme Court has declared that there is a 14 Constitutional protected right under the First 15 Amendment to make audio recordings of all government 16 activity in which there is no interest which society is ready to recognize, Katz vs. US, in an interest 17 18 in privacy as being reasonable. MR. CARNEY: Mr. More, please finish up. 19 MR. MORE: Okay. My question is: Has that --People vs. Moreno and People vs. Clark, is that now the policy? 23 Are all the members of the City of

BAZAREK: Mr. More, our policies as you 8 know -- we've talked about this before -- Department 9 10 procedure is available to you online. 11 The Chicago Police Department follows the 12 law. MR.
