2	everyone, my name is Lori Lightfoot, and I'm the
3	President of the Chicago Police Board, and I'll
4	be calling the meeting to order now.
5	The first item of business is do I have
6	a motion to allow Police Board Member John
7	Simpson to attend this meeting via telephone?
8	MR. FOREMAN: So moved.
9	REV. EADDY: Second.
10	PRESIDENT LIGHTFOOT: All in favor?
11	(Ayes in unison.)
12	PRESIDENT LIGHTFOOT: Any opposed?
13	Mr. Simpson, can you hear us?
14	MR. SIMPSON: I can hear you.
15	PRESIDENT LIGHTFOOT: Okay.
16	The next item for business is approval
17	of the minutes of the Board's Regular Public
18	Meeting held on August 18th, 2016. Is there a
19	motion to approve the minutes?
20	MS. SWEENEY: So moved.
21	MR. FOREMAN: Second.
22	PRESIDENT LIGHTFOOT: All those in
23	favor?
24	(Ayes in unison.)



1	PRESIDENT LIGHTFOOT: Anyone opposed?
2	The motion passes.
3	Our next regular public meeting will be
4	on Thursday, October 20th, here at Chicago
5	Public Safety Headquarters at 7:30 p.m.
6	At this time, I ask for a motion to
7	close a series of executive sessions for the
8	purposes of considering personnel matters and
9	litigation, as authorized by Sections $2(c)(1)$,
10	(3), (4) and (11) of the Illinois Open Meetings
11	Act. Is there such a motion?
12	MS. FRY: So moved.
13	MR. FOREMAN: Second.
14	PRESIDENT LIGHTFOOT: All those in
15	favor?
16	(Ayes in unison.)
17	PRESIDENT LIGHTFOOT: Any opposed?
18	The motion passes.
19	A report of disciplinary actions taken
20	by the Board during the previous month has been
21	made available at this evening's meeting. This
22	report and the Board's written Findings and
23	Decisions are posted on the Board's website.
24	The Police Board, as authorized by the

Open Meetings Act, has considered in a closed 1 2 meeting two disciplinary cases. The Board will now take final action on these cases. 3 4 Regarding Case No. 16 PB 2899, is there a motion to find Police Officer John Loconsole 5 6 quilty of violating Department rules by working 7 secondary employment while on the medical roll 8 and to suspend him for 18 months? 9 MS. FRY: So moved. 10 MR. FOREMAN: Second. 11 PRESIDENT LIGHTFOOT: All in favor? 12 (Ayes in unison.) 13 PRESIDENT LIGHTFOOT: We need to have a 14 show of hands. 15 Any opposed? None. Voting in favor are Board Members 16 17 Foreman, Delgado, Eaddy, Fry, Simpson, Sweeney 18 and myself. The motion passes by a unanimous 19 vote. 20 Is there a motion to adopt the written 21 findings and decision that has been reviewed by 22 all Board members who participated in the case? 23 MS. FRY: So moved. 24 Second. REV. EADDY:

5	Regarding Case No. 16 PB 2903, is there

8	and a sergeant in the Medical Services Section
9	and to discharge her from the Chicago Police
10	Department?
11	MS. FRY: So moved.
12	MS. DELGADO: Second.
13	PRESIDENT LIGHTFOOT: All in favor may
14	I have a show of hands of all those in favor?
15	That's Lightfoot, Foreman, Delgado, Fry and
16	Sweeney voting in favor.
17	And those opposed?
18	MR. SIMPSON: I respectfully dissent.
19	PRESIDENT LIGHTFOOT: That's Reverend
20	Eaddy and John Simpson voting against.
21	MR. SIMPSON: Ms. Lightfoot, I oppose
22	the termination.
23	PRESIDENT LIGHTFOOT: And, Reverend
24	Eaddy, you also vote opposed, is that correct?



1 REV. EADDY: Yes. 2 PRESIDENT LIGHTFOOT: Those who voted 3 in favor of quilt are Board members Foreman, 4 Delgado, Fry, Sweeney and myself. Board members 5 Eaddy and Simpson oppose the termination decision. The motion passes by a vote of 5 to 6 7 2. Is there a motion to adopt the written 8 findings and decisions, including the dissent, 9 that has been reviewed by all Board members who 10 11 participated in the case? 12 So moved. MS. FRY: 13 MR. FOREMAN: Second. 14 PRESIDENT LIGHTFOOT: All in favor? (Ayes in unison.) 15 PRESIDENT LIGHTFOOT: Any opposed? 16 17 That motion passes by a unanimous vote. 18 The Board's decisions in the cases on which we took final action this evening will be 19 20 entered as of today's date, and will be issued 21 to the parties. A copy of each of the written 22 decisions will be posted on the Board's website within 10 business days pursuant to the 23 24 Municipal Code of Chicago.



1 I now call on Board member Foreman. 2 Three-member panel case MR. FOREMAN: 3 16 RP 02, Michael Mette, pursuant to Section 2-57-060(c) of the Municipal Code of Chicago, a 4 5 panel of three members of the Police Board has 6 considered in a closed meeting, as authorized by 7 the Open Meetings Act, one matter on which the 8 Chief Administrator of the Independent Police Review Authority and the Superintendent of 9 Police did not agree regarding the discipline of 10 11 a police officer. The members of the panel, 12 Board members Delgado, Simpson and myself, will 13 now take action to resolve the issue regarding 14 the recommendations for discipline. Regarding case number 16 RP 02, which 15 involves allegations of the use of excessive 16 17 force by Police Officer Michael Mette, is there 18 a motion to find that the Superintendent's response does not meet the burden --19 20 PRESIDENT LIGHTFOOT: One moment, we're 21 having technical difficulty. 22 MR. SIMPSON: Hello. I'm sorry, we got 23 cut off.

PRESIDENT LIGHTFOOT: Let me just say

for the record Board member Simpson has rejoined 1 2 us. MR. FOREMAN: Regarding case 16 RP 02, 3 4 which involves allegations of the use of excessive office by Police Officer Michael 5 6 Mette, is there a motion to find that the 7 Superintendent's response does not meet the burden of overcoming the Chief Administrator's 8 9 recommendation for discipline? 10 MS. DELGADO: So moved. 11 MR. SIMPSON: Second. 12 All in favor? MR. FOREMAN: 13 (Ayes in unison.) 14 MR. Good evening, Ms. Noel.

MS. NOEL: Good evening, everyone. How are you? The report on -- the report from the United Nations Working Group of Experts on People of African Descent on its mission to the United States of America, I'm not sure if you know, but they came here in January of this year, and this is their final report. And I just have a few things I wanted to read from it.

The Working Group considers that Civil Rights laws are not being -- working group that -- working group considers that Civil Rights laws are not being fully implemented. And even if fully implemented, they are insufficient to overcome and transform the institutional and structural racial discrimination and racism against African descended people. Mass incarceration, police violence, housing segregation, disparity and the quality of education, labor markets segmentation, political disenfranchisement and environmental degradation continue to have detrimental impacts on people of African descent despite the application of Civil Rights laws.

Under manifestations of racial 1 discrimination, the criminal justice system and 2 barriers to civil and political participation, 3 the Working Group is deeply concerned that the 4 alarming levels of police brutality and 5 6 excessive use of lethal force by law enforcement officials committed with impunity against people 7 8 of African descent in the United States. 9 addition, the most recent and well-known cases 10 of killings of unarmed African Americans, such 11 as the cases of Eric Garner, Michael Brown, 12 Tamir Rice, Walter Scott, Freddie Gray, and Laquan McDonald, the Working Group received 13 14 information about many other similar cases.

In

The Working Group met with a considerable number of relatives of African Americans allegedly killed by police officers, they were actually killed by police officers, but they say allegedly. They are still seeking justice for their loves ones, including Tyron West, Tyron Lewis, Jonathan Sanders, Oscar Grant, Tony Robinson, Marion Brown, India Kager, Ronald Johnson, that's Dorothy's son, Mohamed Bah, Rekia Boyd, you know her, Sandra Bland, you

know her, and Alonso Smith. 1 2 They also -- and I'll be sending you 3 guys this report. You all want it? 4 (Board Members replied yes.) 5 MS. NOEL: The Working Group was informed that the war on drugs has had a 6 7 devastating impact on African Americans, and the 8 mass incarceration was considered a system of 9 racial control that operated in similar ways to 10 how Jim Crow laws once operated. 11 Thank you. MR. FOREMAN: 12 MS. NOEL: I'll send it out. Anybody want this copy? 13 14 PRESIDENT LIGHTFOOT: You can give it 15 to Mr. Caproni and he'll circulate it. 16 The next speaker is Darva Watkins. 17 Ms. Watkins here? 18 The next speaker is Queen Sister. 19 she here? 20 And our final speaker is Robert More. 21 Is Mr. More here? 22 At this time all persons who have 23 signed up in advance to speak have been called 24 or recognized.
