MESSAGE FROM THE COMMISSIONER

Over the last three years, Chicago's Department of Cultural Affairs and Special Events (DCASE) has invested unprecedented funding to support artists and the creative economy, and expand access and participation in the arts throughout Chicago's 77 neighborhoods. In collaboration with the Department of Planning and Development and the Department of Transportation, we've committed over \$12 million for public art in all ten neighborhoods of Mayor Lightfoot's INVEST South/West initiative.

To determine where and how that funding manifests in new public art, we assembled a team of some of Chicago's most talented and most generous artists to develop Public Art Vision plans within each neighborhood that identify priorities for public art investments that create new and innovative uses of the public way. Through the Public Art Reimagining Tour with You (P.A.R.T.Y.), artists have led this planning process starting in Auburn Gresham, Austin, Bronzeville and Englewood, creatively bridging the complexity of government processes with authentic dialogue around community needs and dreams.

In this report, you'll find the results of months of rich conversations and workshops amongst artists, residents, business owners, elected officials, community organizers, and more. You'll learn how each neighborhood reflected about its past and present cultural identity, its visions for reshaping the visual landscape of central commercial corridors and beyond, and the role they envision for public art in contributing to those aspirations – including priority projects identified for the City to fund starting in 2023.

I extend my sincere gratitude to the incredible artist cohort whose energy, creativity and commitment has made P.A.R.T.Y. a meaningful and joyful experience: Englewood Arts Collective, Floating Museum, and Vanessa Stokes/VS Creative Consulting, along with planning and urban design firms Borderless Studio and PORT.

The future of public art is bright in Chicago, and we look forward to keeping the P.A.R.T.Y. going in all ten INVEST South/West neighborhoods.

EXECUTIVE SUMMARY

At the outset of the INVEST South/West initiative, The Department of Planning and Development (DPD) and the Department of Transportation (CDOT) identified priority investment corridors in each neighborhood for significant streetscape and public realm enhancements, including new roadways, sidewalks, light poles, bike lanes, landscaping and community plazas. In order to align public art investment with CDOT corridor renovation projects and DPD investment strategies, Chicago Department of Cultural Affairs and Special Events (DCASE), initiated an artist-led public engagement campaign, titled P.A.R.T.Y. (Public Art Reimagining Tour with You) to inform a Public Art Vision for each of the ten INVEST South/West neighborhoods.

The first phase of the P.A.R.T.Y. campaign was carried out over the Summer and Fall of 2022 and focused on four neighborhoods: Auburn Gresham, Austin, Bronzeville and Englewood. The artistled engagement teams organized and carried out a sequence of four public events in each neighborhood, ranging from neighborhood walks, event pop-ups and community conversations.

This report documents the values, stories, themes and priorities shared by community members throughout the engagement sessions so that these key narratives may be reflected in new permanent public art installations in Englewood. It identifies the type and location for actionable public art projects strategically aligned with ongoing DPD- and CDOT-led INVEST South/West priority corridor capital projects.

Throughout the community events of the Public Art Reimagining Tour, Englewood residents and stakeholders provided a broad range of ideas and input about what they would like to see reflected in public art in their community. These insights are organized in four main categories representing possibilities for themes and storytelling shaping public art projects:

Community + Belonging Black History + Culture Environment + Resilience Wellness + Safety

DCASE, in collaboration with partner departments, will **develop and issue requests for artists** to submit qualifications to be commissioned for the design and installation of public art projects in Englewood.

The three primary opportunities identified in the report for new permanent public art investment in Englewood are:

- 1) A gathering installation at Englewood Plaza on 63rd Street;
- 2) A mural at Englewood Plaza on 63rd Street; and
- 3) Various installation and sculpture opportunities along the Englewood Nature Trail.

The community also expressed a strong interest in design processes that are inclusive and engage members to be involved in the process of design and implementation of public art.

Therefore, this vision document will **serve as a resource for commissioned artists** as they develop and lead a community-centered engagement, design and installation processes for their permanent public art implementation projects in Englewood.

INTRODUCTION: INVEST SOUTH/WEST + P.A.R.T.Y.

INVEST South/West is an unprecedented community improvement initiative by the City of Chicago that is strategically reversing decades of systemic public and private disinvestment within the city's West and South Side neighborhoods.

Initiated in Fall 2019 and supported by more than \$750 million in public funding, INVEST South/
West is enhancing 12 commercial corridors in 10 neighborhoods with focused improvements that include new, mixed-use construction projects, the adaptive reuse of historic buildings, new plazas, small business grants, and related public realm improvements that restore neighborhood vitality and provide a catalytic foundation for ongoing public and private investment.

As of Fall of 2022, the City has aligned more than \$2.2 billion in public and private investment, and has invested more than \$1 billion in public funding. The initiative is providing support for small businesses, creating public realm improvements, restoring historic buildings, and fostering equity and resilience where it's needed most.

DCASE also sponsored Artist-in-Residence programs in Englewood, Auburn Gresham, Austin, and New City, where artists assisted City agencies and community stakeholders on projects that leverage local culture and creativity as part of integrated neighborhood improvement plans. P.A.R.T.Y. is an extension of these efforts.




Figure 1-INVEST South/West neighborhoods

P.A.R.T.Y PUBLIC ART REIMAGINING TOUR WITH YOU

The artist-led cohort facilitated opportunities to engage in conversations with the Englewood community throughout three distinct phases, and collected input and feedback related to:

- WHAT: Stories, themes, narratives, ideas
- WHERE: Site opportunities, types of spaces
- **HOW**: Art type, size, form

This process also brought visibility to the multiple overlapping projects converging around neighborhood improvements such as public infrastructure investment by the City, private development, and community-led initiatives that emphasized the need for continued alignment and coordination.

This integrated understading helped to identify these three **goals for public art** project opportunities:

- Amplify: public art that contributes to planned or ongoing investment in neighborhoods
- Revitalize: public art that inspires and invites different activities through renewed identity of public places
- Catalyze: public art that catalyzes new investment and neighborhood improvements

Finally, community also expressed a strong support for a multi-phased inclusive engagement process that involves a broad spectrum of participation - from ideation to implementation of public art:

- · Brainstorming and idea generation
- Prototyping and feedback
- Activation and programming

GUIDING PRINCIPLES

This Public Art Vision Plan aims to widen the discussion regarding the role of public art in the lives, surroundings, and legacies of Chicago communities. The visioning process intentionally emphasized the necessity of public art investments. Public art, in addition to beautifying, can:

- Contribute to a neighborhood's vitality & safety
- Support economic development
- Create Unique Cultural Destinations
- · Reflect Inclusive Processes

Public Art Requests for Proposals (RFPs) will include reference to these guiding principles - and emphasize engagement as an expected approach to create more inclusive processes that result in public art outcomes reflecting more meaningfully community identity and stories.

IMPROVE NEIGHBORHOOD LIFE & SAFETY

Public art can take different shapes to improve the safety and livelihood of communities. A few examples are activation of sidewalks with street furniture, traffic calming curb extensions and painting and diverse street lighting.

INTRODUCTION: GREATER ENGLEWOOD IN CONTEXT

Greater Englewood, consisting of the Englewood and West Englewood communities, is one of 10 priority areas selected as a part of the initial phase of INVEST South/West. Launched in October 2019, INVEST South/West's goal is to re-activate neighborhood cores that have historically served as focal points for pedestrian activity, shopping, services, transportation, public spaces and qualityof life amenities for local residents. In Greater Englewood, the priority focus is the intersection of 63rd and Halsted streets and adjacent blocks.

Greater Englewood is bordered by West Garfield Boulevard to the north, West 75th Street to the south, South Racine Avenue to the west, and South State Street to the east. It is located approximately seven miles from the Chicago Loop which includes the City's central business district. According to the Chicago Metropolitan Agency for Planning, Englewood has a total population of 23,792 with 9,101 total households and an average household size of 2.6. The community is 94.1% Black non-Hispanic, 4.3% Hispanic or Latino, 0.7% White non-Hispanic, and 0.3% Asian non-Hispanic. The median age is 33.8, with 28.8% of the population 19 years old or younger and 13.8% 65 years old or older. Median income is \$21,275.

63rd Street and Halsted Street are key neighborhood corridors through the Englewood community and the source of new energy and investment aligned with recent redevelopment processes spearheaded by the Department of Planning and Development through Requests for Proposals, as well as active business owners, non-profit leaders, residents, and artists. Neighborhood organizations and civic leaders, such as the Greater Englewood Community Development Copororation (GECDC), Greater Englewood Chamber of Commerce, Grow Greater Englewood, Inner-City Muslim Action Network (IMAN), Residents

Association of Greater Englewood (R.A.G.E.) are actively involved and invested in different projects recognizing the potential as an economic and cultural driver for 63rd and Hasted Streets.

Among key catalytic plans and projects under development are **Englewood Connect** at Englewood Plaza, The Englewood Nature Trail, and Go Green on Racine which includes a Community Fresh Market and The Regenetator at former Woods Academy.

The planned Englewood Trail (formerly, the 59th Street Line) is a 1.7-mile long former Norfolk Southern elevated rail line that will be converted into a multi-use trail to provide recreation, transportation, cultural amenities, and connections to other key parks, schools and assets in and near the Englewood community.

Just north of the ISW development sites, the Department of Cultural Affairs & Special Events (DCASE), the Department of Planning and Development (DPD), and the Chicago Department of Transportation (CDOT) partnered to renew the former rail viaduct located at 5800 S. Halsted. In 2020, DCASE commissioned the Englewood Arts Collective to create a "gateway" mural that signals entrance to the nearby commercial district at 63rd and Halsted. DCASE also launched the INVEST South/West Artist-In-Residence program, which is investing in local artists in multiple neighborhoods, including Englewood. Local artist Eric Hotchkiss was selected to work directly with DCASE, DPD, and other city agencies, local organizations, and residents to develop and implement a series of community engagement, public art, and site-specific cultural programs that reflect each neighborhood's history and residents to create spaces that promote the health, happiness and well-being of the entire community.



PLANNED + ONGOING CATALYTIC PROJECTS

This Public Art Vision seeks to align with other initiatives that have been identified as catalytic projects aming to transform the neighborhood in the coming years while improving its vibrancy and vitality. One catalytic project is the ISW Corridor Improvement Project led by CDOT focused on 63rd and Halsted Streets. It includes improvements of sidewalks and street intersections, as well as street lighting and other wayfinding elements. Additional projects that also represent opportunities for public art interventions are:

- The Englewood Nature Trail, a two-mile long green infrastructure reuse project that will turn abandoned railway tracks into a walking and cycling trail.
- Englewood Connect, "eco-food hub" that will establish culinary-related uses that empower, employ and feed local residents.
- Go Green Fresh Market and Plaza, a communityrun grocery store and a future plaza attached to it.
- The Regenerator, a hub for housing, reentry services and green innovation at former Woods Academy.







INVEST SOUTH/WEST PRIORITY CORRIDOR: 63RD STREET + HALSTED AVENUE

The INVEST South/West Priority Corridors for Englewood includes the section of 63rd Street between Loomis Boulevard and Wallace Street and Halsted Street between 59th Street and 66th Street. CDOT improvements to the streetscape will include, but are not limited to, widened sidewalks and bump outs, new lighting, bike lanes, youth led seating designs referred to as peace circles, light-pole neighborhood identifiers and two priority corridor gateways. DCASE will work closely with CDOT to complete these planned improvements in two phases which will shape the future vibrancy of the corridor.

(15) Libations to the Ancestors Garden

The planned CDOT improvements to the 63rd Street Priority Corridor will ultimately create more public space, near-term opportunities for public art that can interpret Englewood's history and additional communal spaces that foster meaningful community interactions.

WHAT WE FOUND: EXISTING PUBLIC ART NARRATIVES IN GREATER ENGLEWOOD

Cultural narratives are stories told by a group of people about themselves, their shared ideals, and their experiences. Cultural narratives influence the character of a location and impact the values of the people in that area. Identifying existing cultural narratives is the first step to understanding which untold stories should be represented in public spaces.

Englewood's public art narratives are shaped by the strength and compassion of its community. By documenting existing public art in Englewood, three main overarching themes were have been identified to create cultural context for new public art:

- Unity + Social Justice
- Wellness + Resilience
- Hope + Imagination


ENGLEWOOD PLAZA GATHERING INSTALLATION


As part of the ISW Streetscape improvements, CDOT is working with the Greater Englewood CDC to renovate and revive the identity of the Englewood Plaza. Current conditions consist of a vacant Boombox installation and large planters. Its proximity to the S Halsted Avenue and 63rd Street priority corridor intersection and visual relationship to the CTA Green Line makes it a prime location for public art to showcase Englewood's identity and culture.

The plaza improvement project is led by CDOT team, in collaboration with community partners Greater Englewood Community Development Corporation.

This gathering installation is proposed to be integrated into the plaza improvements, and as an opportunity for visual identity and placemaking.




Figure 6-Contextual considerations for proposed Gathering Landmark

PUBLIC ART OPPORTUNITY 02

ENGLEWOOD PLAZA MURAL

In coordination with the Englewood Plaza improvements, a mural is envisioned as an improvement for the Englewood Plaza. The mural is proposed on the side of the building creating the western edge of the plaza. While the building is currently vacant, it has a strong potential to be reactivated with its position along the 63rd Street INVEST South/West Priority Corridor. The mural has the opportunity to set a powerful narrative for Englewood as it will be visible from the corridor and the CTA Green Line.

DCASE will collaborate with CDOT and community partners including The Greater Englewood Community Development Corporation to coordinate project implementation.




Figure 7-Mural design considerations




Figure 8-Proposed mural location

ADDITIONAL OPPORTUNITIES: ENGLEWOOD NATURE TRAIL

The Englewood Nature Trail, an collaborative effort by CDOT and DPD, seeks to transform an abandoned elevated railroad corridor into a 1.75 mile nature and walking path. The Invest South West 63rd Street corridor connects with the proposed trail on Halsted Street, offering opportunities for city agencies and residents of Englewood to collaborate in shaping public art and the overall vision of this public space. The future site of the trail is parallel to 59th Street between Lowe Avenue and Hoyne Avenue, with potential intersections for art activations noted at Racine Avenue and Halsted Avenue.

DCASE will continue coordination with CDOT, DPD and community partner Grow Greater Englewood to recommend public art project opportunities.



NEIGHBORHOOD WALK

ENGAGEMENT SUMMARY

The neighborhood tour took place on June 25, 2022, starting at the Boombox Plaza at 63rd St. Before any community engagement was held, the P.A.R.T.Y. team met with local stakeholders to listen and learn about areas of opportunity for public art in the neighborhood:

- Projects and initiatives in the pipeline
- Existing infrastructure
- Areas for intervention for improved safety

Englewood Arts Collective helped organize this tour to speak with stakeholders in the community and introduce the planning and engagement process.

This neighborhood tour included stops and conversations at the following locations:

- 1. Boombox Plaza on 830 W 63rd St
- 2. Englewood Village Plaza on 5800 S Halsted (Grow Greater Englewood)
- 3. Go Green on Racine & Woods Academy on 6210 S Racine
- 4. R.A.G.E. Plaza on 6622 S Union Ave




Figure 11-Map of neighborhood walk

FOLLOW THE TRACES

The vacant lot on the SW corner of 63rd and Halsted currently has a "desire-line" path corner to corner – could the highly visible site be activated in some way in the near-term?

ACTIVATE IN-BETWEEN SPACES OPPORTUNITIES

There are numerous large vacant lots on 63rd between Racine and Carpenter.

There is momentum for Halsted and Racine intersections, but what can be done in-between?

KEEP BUILDING ON THE MARKET-LED ACTIVATIONS

Grow Greater Englewood is increasing activaties and programming in this plaza with the market days, music events, pop-up art and semi-permanent design installations.

This plaza acts as the gateway for the Englewood Nature Trail.

PHASE 1 - AWARENESS


ENGAGEMENT SUMMARY

This Phase 1 event was held on July 10, 2022, at the Englewood Village Plaza at the intersection of Halsted and 63rd. The goals of this first event were to:

- Introduce the artist cohort, the planning process and timeframe of this campaign, and the funding ready/available for investment in public art projects.
- Gather initial insights and input about themes, ideas, locations and types for public art possibilities.
- Inspire new possibilities for permanent public art through the public art catalog.

This artist-led pop-up joined the event series Vinyl & Vittles hosted by Grow Greater Englewood at the Englewood Village Plaza. Some of the conversation questions and prompts included:

- What does public art mean to you?
- What stories from the community should be celebrated or acknowledged?
- In which places would public art investment support neighborhood vibrancy and safety?
- What sites and why could be key places for public art?



The Public Art Catalogue was a key part of the engagement toolkit used to elicit input from the community about what types of public art they prefer and why. This catalogue compilled nearly 50 examples of implemented public art pojects located in Chicago, the U.S. and the world.

The P.A.R.T.Y Phase 2 event took place at the Parker Community Academy on September 8, 2022, in conjunction with the Englewood Nature Trail meeting.

The goals of the second event were to identify potential themes and locations for public art in the neighborhood - and also reference oportunities about the connections of the Invest South West corridor and the Englewood Nature Trail.

The Floating Museum led the artist cohort presesentation, and solicited written feedback from resdients and community members using the following prompts:

- · What should be honored in Englewood?
- What would you like public art to do for Englewood?
 And where?

- "Public art should take pictures of youth and make more senior citizens be appreciated by the residents."
- "Public art should be a tribute to Block Club Presidents. My grandmother was a BCP from the 70s-80s. 5724 S. May."

- · "Public art should highlight artists from Englewood."

WELLNESS + RESILIENCE

PHASE 3 - RESPOND

ENGAGEMENT SUMMARY

Phase 3 event was held on November 9, 2022 at the Go Green Community Fresh Market.

Its main goals were to:

- Provide overview of PARTY / Public Art Planning
- Report back on what was heard in the previous phases
- Engaging communty in responding to project opportunities
- Provide clear understanding of next steps

Two project opportunities were presented to the community:

- A gathering installation on Englewood Plaza
- A mural at Englewood Plaza

In addition to sharing their views on the projects above, participants also engaged in conversation sparked by the following questions:

- How can these projects have the most impact and benefit?
- How could they amplify or catalyze ongoing projects and initiatives?
- What else should be considered?
- How these projects could reflect / respond to community need?
- · How can the RFQ/RFP process be more inclusive?

INCLUSIVE PROCESS

- "The language in RFPs can deter people with less experience in large scale public art from applying. How can there be more equity in the process?"
- "The process should include both a RFQ and RFP, where in the RFQ multiple submission formats could be accepted (power points, video, text, drawing, etc.) for those who don't have experience with standard tools.
- "The panel for reviewing the RFQ should be a full community led group, which would pick finalists to submit RFPs. A second panel, then, could include a variety of people who understand building limitations in the public way."
- "The selection process should be collaborative, where artists without large scale building experience can be hired to design and paired with a fabricator."

- "There should be video tutorials explaining the RFP process for amateurs"
- "RFPs should be very clear about timelines."
- "There could be a community nomination process for the RFPs."
- "Artist cohorts can be clicky, and encouraging community nomination might make it harder for up and coming artists to participate"
- "The City could provide resources for finding vendors and fabricators, who should also be rooted in Englewood."
- "There should be multi-generational representation and participation."



Public Art Reimagining Tour November 2022

ART THEMES AND TYPOLOGY

- "Art should be able to uplift the future green line station"
- "It's important to start from a history of abandonment, a remembrance of what used to exist before the city removed elements like the CTA green line station. Art should also acknowledge the fact that Englewood was a transportation / commercial hub, reference the comic book culture, etc."
- "There should be emphasis on past and future residents of the neighborhood."
- "History, tradition, the Great Migration." "Functional spaces that emphasize play."
- "Wayfinding pieces for getting off the Green Line."
- "Englewood neighborhood markers as connection to Midway + Presidential Library."

POTENTIAL LOCATIONS

- "Future Green Line station."
- "Art that can uplift the existing streetscape project happening on 63rd."
- "Intersections of 55th, 59th and 63rd with Halsted and Ashland."

LIMITATIONS AND CONCERNS

- "The RFP should be very explicit with CDOT public way requirements like footings, height, and limitations for particular sites."
- "The boundaries of the ISW corridor should be reconsidered."
- The RFP should be transparent about requirements such as insurance and budgets so that artists can be realistic about the budget that they are provided with."

ENGAGEMENT SUMMARY

COMMUNITY MAPPING

Throughout community engagement events, community members and stakeholders pointed out potential locations and projects that could help activate or revitalize different areas of the neighborhood. They identified places and suggested public art typologies and programs that could help activate or revitalize different areas of the community. A few proposals heard from Englewood residents and stakeholders were:

- · To include art that focuses on the history of Englewood and Ogden Park at Ogden Park
- To add a wood sculpture on a vacant lot at the intersection of Honore St and 63rd St
- To provide interactive art for youth near schools
- To create an agricultural art sculpture at the Englewood Village Plaza to cover the WIFI tower


