**CHICAGO** — In a press conference earlier today, Mayor Lori E. Lightfoot joined Chicago Department of Public Health Commissioner, Dr. Allison Arwady, to announce "Protecting Chicago" – a five-phase framework that the City will be using to guide Chicago's reopening process amid COVID-19.
