Chicago Public Library YOUmedia Digital Learning Space for Youth – Branch locations

Funding for the expansion of the YOUmedia teen spaces to branch locations came through the Broadband Technology Opportunities Program (BTOP) grants, funded by the Recovery Act. Working with the City's Department of Innovation and Technology, and together with MacArthur Foundation matching grants, Chicago Public Library expanded YOUmedia to three neighborhood locations.

The grants identified five **Smart Communities** on which to focus these efforts: Auburn Gresham, Chicago Lawn, Englewood, Humboldt Park and Pilsen. The Library chose three of those into which to expand YOUmedia

- a. Thurgood Marshall Branch in Englewood (7506 S. Racine Ave.)
- b. Rudy Lozano Branch in Pilsen (1805 S. Loomis St.)
- c. Richard M. Daley Branch in W. Humboldt Park (733 N. Kedzie Ave.)

Note: **The Smart Communities program** works to increase digital access and use by families, businesses and other institutions in five moderate- and low-income Chicago neighborhoods: Auburn Gresham, Chicago Lawn, Englewood, Humboldt Park and Pilsen. GOING FORWARD:

The Chicago Public Library is evaluating space in existing branches in order to allow for teen areas. As funding becomes available for more YOUmedia programs and hardware, the Library plans to expand the program further.

New Library branches are being designed to include teen spaces, where the demographics of the neighborhood demand it.

The Library is also working with partners to develop some traveling programs which can be brought to branches throughout the city to allow teens to learn new digital skills.
