Enclosed, please find the information that you have requested pertaining to the Commission on Human Relations 2014 annual budget. It is our understanding that the remainder of the information that you have requested was provided to you by the Office of Budget and Management, specifically questions 1-5, 7, and 8.

Question #6: Hearing Officers and Mediators. Please see the attached list.

Question #9: Damages assessed through administrative hearings.

Administrative hearings are only scheduled after a full investigation by the Commission on Human Relations and a finding of substantial evidence by the Commission's Executive Compliance Staff of attorneys. Once parties are notified of a substantial evidence determination, many cases settle particularly in 2013 when compared to 2012. Thus settlement may include a financial payment to compensate the victim, and precludes the time and expense of a hearing. Therefore, the total dollar amount awarded by the Commission on Human Relations is not indicative of the number of cases which advance to the hearing process.

2012

Damages: 50,516.45

Fines Payable to the City: 2,500

Attorney's Fees: 159,618.08

2013

Because all of the cases scheduled thus far in 2013 (excluding hearings for attorney's fees), have closed before the hearing process had begun or had been completed, there have been no awards of damages or orders to pay fines. Of the 20 cases scheduled for hearing, 16 were settled, 2 were dismissed for failure to cooperate, and 2 were withdrawn (which may or may not have been due to a private settlement).

The attorney's fees represent cases decided in 2012. Damages and fines for those cases were awarded in 2012. The attorney's fees were awarded in 2013 following separate hearings only for the purposes of deciding attorney's fees.
