The information provided below is in response to questions posed at our department's hearing on October 31, 2014, to discuss the proposed 2015 budget.

Alderman Mary O'Connor asked about non-federally funded construction contracts at O'Hare that require 7.5% of the hours worked by project area residents. Specifically, what the 'project area' is for these projects at O'Hare, have the goals been met, and what projects have been put to bid?

The 'project area' designated for O'Hare Airport under the 7.5% Local Hiring Ordinance includes seven communities: Edison Park, Sauganash, Forest Glen, Jefferson Park, Portage Park, Dunning, and Chicago O'Hare International Airport.

Since the approval of the ordinance, CDA has begun one non-federally funded construction project under the local hiring initiative - the Terminal 5 roof replacement project. At this time, the project is expected to meet the local hiring requirement.

Three additional projects with the local hiring requirement at O'Hare have been bid out but not yet awarded including ATS Painting Structures, Stations and Bridges; and the Upper Level Expansion Joint project. Seven projects with the local hiring requirement at O'Hare will soon go out to bid: Chillers 1, 2, 3, 4, and 5 and South Cooling Towers; American Airlines Bag Room HVAC Upgrades; Landside Terminal PCC Pavement Replacement; I-190 Lift Station; Baggage Alley Road Wall Repair/Replacement; H&R Roof Replacement; and ARFF Large Frame Aircraft Training Mock-Up.

For Midway, the 'project area' includes five communities: Garfield Ridge, Clearing, Archer Heights, West Elsdon, and West Lawn.

Upcoming contracts with the local hiring requirement at Midway include the following three projects: Guard Booths Enhancements project at 55th and 63rd (expected to be advertised in the next few weeks); Landside Parking Lot Improvements project (expected to be out to bid in the 1st quarter of 2015); and Curbside Enhancement project (expected to be advertised in the 2nd quarter of 2015).
