The attached information is in response to questions posed at our department's hearing on September 30, 2015 to discuss the proposed 2016 budget.

Alderman Leslie A. Hairston asked for the following:

For the 73,000 added jobs in Chicago since 2011, are those workers from the local neighborhoods?

Employees who work in Chicago live throughout our neighborhoods and the surrounding metro area, and the Census surveys which generate the number of net new jobs for the city each year do not capture how many of those workers are city residents. But specifically for investments facilitated by DPD that lead to the creation or retention of jobs, DPD requires developers to strictly adhere to City residency hiring requirements for construction and to work with the department to hire locally as much as possible.
