The attached information is in response to questions posed at our department's hearing on October 5, 2015 to discuss the proposed 2016 budget.

Alderman Ervin asked how many complaints against Chicago Police Officers assigned to O'Hare and Midway airports were registered by IPRA this year.

As of September 30, 2015, IPRA received a total of 38 complaints against police officers assigned to O'Hare airport, and a total of 22 complaints against police officers assigned to Midway airport.
