The attached information is in response to questions posed at our department's hearing on October 27, 2016 to discuss the proposed 2017 budget.

Alderman Ervin asked for information on the statistical analysis that was being conducted on police deployment to include what factors are being used to make the determination, what is going to be weighted and what is the methodology on obtaining the statistics?

The Chicago Police Department is retaining two experts to conduct a statistical analysis and to help develop the deployment plan. The deployment study will be conducted by Alexander Weiss, Alexander Weiss Consulting, LLC and Paul Evans, Former Superintendent, Boston Police Department.

The team will conduct what is known as a workload-based analysis, which evaluates the demands and responsibilities of patrol officers in the various police districts. The analysis then estimates the approximate number of officers needed to handle those tasks and provide appropriate levels of service in each of the districts.

This methodology permits the department to set benchmarks for officer time allocated between response-based policing and proactive measures. The analysis will include calls for service, district geography, officer relief factor, ensuring flexibility to adjust and respond to emerging problems and issues across the City, and other factors yet to be determined.
