Alderman Burnett asked for information on all electronic options that CPL has for patrons, including audiobooks, eBooks, Zinio, etc.

CPL provides the following electronic options for all Chicagoans:

- OverDrive: Access to thousands of eBook and eAudiobook titles in a variety of languages and levels, including for Kindle devices
- Hoopla: Streaming and downloadable access to more than half a million eAudiobook, eBook, digital graphic novel, music, film, and television titles
- RBdigital eAudiobooks: Exclusive unabridged digital audiobook content from both major and independent publishers
- RBDigital Magazines (formerly "Zinio")": Digital access to more than 250 magazines in a variety of languages and levels
- Flipster: Access to digital magazines exclusive to this service, including *Bloomberg Businessweek, Ebony, Entertainment Weekly, Essence,* and *People*

CPL also provides access to more than one hundred electronic reference databases and informational sources including *Booklist*, Business Plans Handbooks, *Chicago Defender* Historical Archive, *Consumer Reports, Enciclopedia Estudiantil Hallazgos*, The HistoryMakers African American

Video Oral History Collection, Hoover's Company Profiles, Illinois Newsstand, Mango Languages, MedlinePlus, *Morningstar*, Oxford Art Online, and *World Book Encyclopedia*.

All Chicagoans have free access via CPL to electronic learning resources such as ABCmouse, for early childhood learning, and Brainfuse, which provides online one-on-one tutoring in English and Spanish for students; preparation tools for the ACT, SAT, GED, and US Citizenship tests; resume coaching; and Microsoft Office support.

CPL's Digital Collections offer electronic content from our special collections and archives such as photographs of Civil War artifacts, Millennium Park's construction, Mayor Harold Washington, and Chicago neighborhoods, as well as the *Chicago Examiner* newspaper and playbills from Chicago's early theaters.
