Date, Time & Location of Meeting:

On September 9, 2019, at 10:00 a.m., the Committee on the Budget and Government Operations held a meeting in City Hall, Council Chamber, 121 N. LaSalle St., 2nd Floor.

The Committee on the Budget and Government Operations addressed the following items:

1. Approval of the Rule 45 Monthly Report for the July 2019 committee meeting.

3. A communication from the Honorable Lori E. Lightfoot, Mayor, reappointing Jodi L. Block as a member of the Chicago Public Library Board for a term effective immediately an expiring on June 30, 2022. (A2019-42)

Chairman Dowell invited Jodi L. Block to address the committee. Chairman Dowell thanked Jodi Block and opened up for questions. Alderman Austin first spoke and asked questions. Alderman Sposato, Alderman Lopez, Alderman Tunney, and Alderman Moore made comments and asked various questions. Chairman Dowell acknowledged one person who signed up to speak, G. Blakemore. G. Blakemore was not present. Motion made by Alderman Reilly on item number 3, which passed by a voice vote.

Motion to accept the substitute ordinance was made by Alderman Ramirez-Rosa. The substitute ordinance was accepted in Committee. Chairman Dowell introduced Deputy Budget Director Latoya Vaughn and acknowledged the representatives from the various departments in attendance to answer any specific questions. Deputy Budget Director Latoya Vaughn explained the substitute ordinance. Chairman Dowell opened up for questions. Alderman Hadden first spoke on the substitute ordinance and asked questions. Alderman Hairston, Alderman Austin, Alderman Burnett, Alderman Sawyer, Alderman Sadlowski-Garza, Alderman Burnett (Point of Information), Alderman Taylor, Vice-Chairman Silverstein, Alderman Smith, Alderman Reilly, Alderman Ervin, Alderman Lopez, Alderman Osterman, Alderman Curtis, Alderman Moore and Alderman Thompson asked questions and made comments.
